31 (g) Definition.--For the purposes of this section, the term
32 "designated highway work zone" is the portion of an active work
33 zone agreed to by the secretary and Pennsylvania Turnpike
34 Commission where construction, maintenance or utility workers
35 are located on the roadway, berm or shoulder and workers are

1 adjacent to an active travel lane and where an automated
2 enforcement system is active. For the purpose of this
3 definition, workers shall also be considered adjacent to an
4 active travel lane where workers are present and are protected
5 by a traffic barrier.
