Budget Stabilization Reserve Fund.--(a) The 6 following apply: 7 (1) If the balance of the Budget Stabilization Reserve Fund 8 on June 30, 2017, is less than six per centum (6%) of the General Fund revenues received in the 2016-2017 fiscal year, the 9 General Assembly shall appropriate two hundred million dollars 10 (\$200,000,000) to the Budget Stabilization Reserve Fund from 11 revenues received under Article III of the act of March 4, 1971 12 (P.L.6, No.2), known as the "Tax Reform Code of 1971," before 13 June 30, 2018. The appropriation must be transferred to the 14 Budget Stabilization Reserve Fund before the funds generated 15 under Article III of the "Tax Reform Code of 1971" are used for 16 17 other appropriations. This appropriation shall be in addition to transfers required under section 1702-A(b) of the act of April\_ 18 19 9, 1929 (P.L.343, No.176), known as "The Fiscal Code." (2) Each year thereafter, if the balance of the Budget 20 21 Stabilization Reserve Fund on June 30 of the prior year is less 22 than six per centum (6%) of General Fund revenues received by June 30 of that fiscal year, the General Assembly shall 23 appropriate two hundred million dollars (\$200,000,000) to the 24 25 Budget Stabilization Reserve Fund from revenues received under Article III of the "Tax Reform Code of 1971," before June 30 of 26 the subsequent year. The appropriation must be transferred to\_ 27 the Budget Stabilization Reserve Fund before the funds generated 28 under Article III of the "Tax Reform Code of 1971" may be used 29 for other appropriations. This appropriation shall be in 30 addition to transfers required under section 1702-A(b) of "The\_ 31 Fiscal Code." 32 (b) If, at the end of any fiscal year, the ending balance of 33 the Budget Stabilization Reserve Fund equals or exceeds fifteen 34 per centum (15%) of the actual General Fund revenues received 35 36 for the fiscal year, the General Assembly shall enact in separate legislation a refund to taxpayers of the surplus in 37
