19 already developed for content areas assessed by a Keystone  
20 Exam in meeting this requirement.

21 (2) Beginning in the 2016-2017 school year and in each  
22 school year thereafter the clearinghouse shall offer those  
23 online courses from providers that have been approved under  
24 subsection (c) in addition to the courses required to be  
25 offered under paragraph (1). Online courses included in the  
26 clearinghouse from providers under this paragraph shall be  
27 subject to purchase under the provisions of subsection (f).
