7 Consolidated Statutes is amended to read:

9 (a) Regulation.--Every rate made, demanded, or received by
10 any public utility, or by any two or more public utilities
11 jointly, shall be just and reasonable, and in conformity with
12 regulations or orders of the commission. Only public utility
13 service being furnished or rendered by a municipal corporation,
14 or by the operating agencies of any municipal corporation,
15 beyond its corporate limits, shall be subject to regulation and
16 control by the commission as to rates, with the same force, and
17 in like manner, as if such service were rendered by a public
18 utility.

19 (b) Municipal corporations.--In determining a just and
20 reasonable rate furnished or rendered by a municipal corporation
21 or by the operating agencies of a municipal corporation
22 providing public utility water or wastewater service beyond its
23 corporate limits, the commission shall employ an imputed capital
24 structure of comparable public utilities providing water or
25 wastewater service.

(c) Securities of authority.--Notwithstanding any provision
in this title to the contrary:

(1) The commission shall permit an authority to impose,
charge or collect rates or charges as necessary to permit the
authority to comply with its covenants to the holders of any
bonds or other financial obligations.

(2) The commission may not require an authority to take
action or omit taking any action under this title if the
action or omission would have the effect of causing the
interest on tax-exempt bonds or other financial obligations
issued by the authority to be includable in the gross income
of the holders of the bonds or other financial obligations
for Federal income tax purposes.

(3) An authority may continue to issue bonds or other
financial obligations on behalf of the authority under 53
Pa.C.S. Ch. 56 (relating to municipal authorities), and as
otherwise provided by law.
