18 Section 4. Conveyance in Stroud Township, Monroe County.

19 (a) Authorization for conveyance.--The Department of General  
20 Services, with the approval of the Department of Military and  
21 Veterans Affairs and the Governor, is authorized on behalf of  
22 the Commonwealth of Pennsylvania to grant and convey to Monroe  
23 County Municipal Waste Management Authority, or its successors  
24 or assigns, the tract of land described under subsection (b)  
25 together with any buildings, structures or improvements thereon,  
26 situate in Stroud Township, Monroe County, for \$45,000 and under  
27 terms and conditions to be established in a Lease with the  
28 Option to Purchase Agreement with the Department of General  
29 Services.

30 (b) Property description.--The property to be conveyed under  
31 subsection (a) consists of approximately 10.01 acres of land and  
32 ancillary buildings located thereon, bounded and more  
33 particularly described as follows:

34 ALL THAT CERTAIN tract, parcel or piece of land situate in  
35 the Township of Stroud, County of Monroe and State of

22 (c) Easements.--The conveyance shall be made under and  
23 subject to all lawful and enforceable easements, servitudes and  
24 rights of others including, but not confined to, streets,  
25 roadways and rights of telephone, telegraph, water, electric,  
26 gas or pipeline companies, as well as under and subject to  
27 lawful and enforceable estates or tenancies vested in third  
28 persons appearing of record, for any portion of the land or  
29 improvements erected thereon.

30 (d) Condition.--The conveyance shall be made under and  
31 subject to the condition, which shall be contained in the deed  
32 of conveyance, that no portion of the property conveyed may be  
33 used as a licensed facility, as defined in 4 Pa.C.S. § 1103  
34 (relating to definitions), or any other similar type of facility  
35 authorized under State law. The condition shall be a covenant  
36 running with the land and shall be binding upon the grantee, its  
37 successors and assigns. Should the grantee, its successors or  
38 assigns permit any portion of the property authorized to be  
39 conveyed in this section to be used in violation of this  
40 subsection, the title shall immediately revert to and revest in  
41 the grantor.

42 (e) Deed.--The deed of conveyance shall be by Special  
43 Warranty Deed and shall be executed by the Secretary of General  
44 Services in the name of the Commonwealth of Pennsylvania.

45 (f) Costs and fees.--Costs and fees incidental to the  
46 conveyance shall be borne by the grantee.

47 (g) Proceeds of sale.--The proceeds from the sale shall be  
48 deposited in the State Treasury Armory Fund.

49 (h) Alternative disposition.--In the event that the  
50 conveyance is not executed per the terms and conditions as  
51 established in the Lease with the Option to Purchase Agreement

1 with the Department of General Services, the property may be  
2 disposed of by competitive bid.  
3 Section 5. Easements by the Department of General Services and

5 (a) Easements by the Department of General Services.--The  
6 Department of General Services, with the approval of the  
7 Governor, is authorized on behalf of the Commonwealth of  
8 Pennsylvania to grant and convey to East Stroudsburg Borough a  
9 certain permanent public sanitary sewer easement and certain  
10 permanent public water supply system easements, situate in East  
11 Stroudsburg Borough, Monroe County and described under  
12 subsection (b), for \$1.00, for the purpose of access to, and  
13 operation, maintenance, repair, replacement, protection and  
14 security of, a sanitary sewer line, two water wells and  
15 appurtenant facilities, under terms and conditions to be  
16 established in separate easement agreements.
