8 Section 1. Sections 5303(b)(1), (3) and (4) and 5306.1(d)(2)
9 of Title 35 of the Pennsylvania Consolidated Statutes are
10 amended to read:

11 § 5303. Telecommunications management.

13 (b) Establishment of 911 board.--There is established a
14 board within the agency to be known as the 911 board. The board
15 shall be comprised of the following:

16 (1) The following State officials, who shall serve as
17 voting members:

18 (i) The director of the agency, who shall act as
19 chairperson.

20 (ii) The State 911 coordinator.

21 (iii) The Commissioner of the Pennsylvania State
22 Police.

23 (iv) The chairman of the Veterans Affairs and
24 Emergency Preparedness Committee of the Senate.

25 (v) The minority chairman of the Veterans Affairs
26 and Emergency Preparedness Committee of the Senate.

27 (vi) The chairman of the Veterans Affairs and
28 Emergency Preparedness Committee of the House of
29 Representatives.

30 (vii) The minority chairman of the Veterans Affairs
31 and Emergency Preparedness Committee of the House of
32 Representatives.

33 (viii) The State Fire Commissioner.

34 (ix) The chairperson of the State Geospatial
35 Coordinating Board.

37 (3) A representative from the following State agencies,

1 who shall serve as nonvoting members, to be appointed by the
2 chief executive or administrative officer of each agency:

3 (i) The Pennsylvania Public Utility Commission.

4 [(ii) The Office of the State Fire Commissioner.]

5 (iii) The Governor's Office of Administration.

6 (4) A representative from the following Statewide
7 associations, who shall serve as nonvoting members:

8 (i) The Pennsylvania Chiefs of Police Association.

38 § 5306.1. Fund.

40 (d) Distribution.--Within 30 days after the end of each
41 quarter, the agency shall determine the amount available from
42 the fund for distribution and make disbursements in accordance
43 with the Statewide 911 plan and this chapter and in accordance
44 with the following:

46 (2) Up to 15% of the amount in the fund shall be used by
47 the agency to establish, enhance, operate or maintain
48 Statewide interconnectivity of 911 systems, including, but
49 not limited to, the use or obligations of money for debt
50 service related to regional or Statewide interconnectivity.
51 Funds under this paragraph may also be used to purchase a

1 Statewide system designed to allow individuals to associate
2 their phone numbers with personal information, such as a
3 physical disability, so that when an individual makes a 911
4 call, the PSAP has the individual's personal information.

6 Section 1.1. Title 35 is amended by adding a section to
7 read:

8 § 5315. Legislative Budget and Finance Committee review.

9 The Legislative Budget and Finance Committee shall review the
10 annual reports required under this chapter as well as the
11 inventory report under section 5314 (relating to inventory) and
12 shall make recommendations on the reauthorization of the
13 provisions of this chapter by June 30, 2020.

14 Section 1.2. Sections 5398, 7102, 7103, 7301, 7302, 7303,
15 7304, 7305 and 7305.1 of Title 35 are amended to read:

16 § 5398. Termination.

17 [This] (a) General rule.--Except as set forth in subsection
18 (b), this chapter shall expire June 30, [2019] 2021.

19 (b) Exception.--Section 5304(c) (relating to counties) shall
20 expire June 30, 2019.
