12 WHEREAS, In 2019, the Pennsylvania Office of Attorney General
13 filed two lawsuits against Purdue Pharma, accusing the company
14 and its owners of a multifaceted, illegal effort to market
15 OxyContin in this Commonwealth; and
16 WHEREAS, Purdue Pharma filed for Chapter 11 bankruptcy in
17 September 2019 as part of a tentative deal to settle more than
18 2,000 opioid lawsuits filed by states, local governments and
19 Native American tribes; and
20 WHEREAS, A collaborative 41-state investigation led by the
21 Pennsylvania Office of Attorney General resulted in a \$48
22 billion agreement in principle from Cardinal Health, McKesson,
23 AmerisourceBergen, Johnson & Johnson and Teva for their roles in
24 fueling the opioid crisis; and
25 WHEREAS, The Commonwealth will receive more than \$53 million
26 as part of a nationwide settlement against Reckitt Benckiser
27 Group for the improper marketing of Suboxone and practices to
28 defraud Medicaid systems in this Commonwealth; therefore be it
29 RESOLVED, That the House of Representatives urge the
30 pharmaceutical companies, manufacturers and distributors of
31 prescription opioid drugs to fully cooperate with the
32 Pennsylvania Office of Attorney General in reaching financial
33 settlements and legal resolutions that reflect the severe,
34 irreversible harm suffered by tens of thousands of Pennsylvania
35 families who have lost loved ones to the opioid crisis and to
36 substance use disorder; and be it further
37 RESOLVED, That the House of Representatives applaud the work
38 of the Pennsylvania Office of Attorney General in combating the
39 opioid crisis in Pennsylvania through its ongoing bipartisan,
40 multistate investigation and litigation in pursuit of justice
41 for the individuals and families across this Commonwealth that
42 have been affected; and be it further
43 RESOLVED, That the House of Representatives urge the
44 Pennsylvania Office of Attorney General, as the top law

1 enforcement officer in this Commonwealth, to continue to pursue
2 all available legal remedies to hold the pharmaceutical
3 companies, manufacturers and distributors of prescription
4 opioids accountable for their practices that caused or
5 contributed to the opioid crisis in this Commonwealth.
