9           (b) Trafficking in minors.--[A person commits a felony of  
10 the first degree if the person engages in any activity listed in  
11 subsection (a) that results in a minor's being subjected to  
12 sexual servitude.] Notwithstanding section 1103 (relating to  
13 sentence of imprisonment for felony), a person shall be  
14 sentenced to a term of imprisonment fixed by the court at not  
15 more than 40 years if:

16           (1) the person violates subsection (a)(1) or (2); and  
17           (2) the violation:

18           (i) results in a minor being subjected to sexual  
19           servitude; or

20           (ii) is part of a course of conduct subjecting  
21           individuals to sexual servitude by the person.
