2 "Final arbitration award." A final and binding arbitration  
3 award issued by a board of arbitration in accordance with the  
4 act of June 24, 1968 (P.L.237, No.111), referred to as the  
5 Policemen and Firemen Collective Bargaining Act.

6 Amend Bill, page 2, lines 28 and 29, by striking out "prior  
7 to accepting a proposed collective bargaining" in line 28 and  
8 all of line 29 and inserting

10 (1) prior to accepting a proposed collective bargaining  
11 agreement as a contract; and

12 (2) after the issuance of a final arbitration award.

22 issuance of a final arbitration award and ending 30 days  
23 after the initial posting.

24 (2) Nothing in paragraph (1) shall prohibit a public  
25 employer from posting notice of a proposed collective  
26 bargaining agreement or a final arbitration award for a  
27 period longer than that required under paragraph (1).
