32 after the effective date of this paragraph.

1           (2) For a health insurance policy for which neither  
2 rates nor forms are required to be filed with the Federal  
3 Government or the department, 40 Pa.C.S. Ch. 47 shall apply  
4 to a policy issued or renewed on or after 180 days after the  
5 effective date of this paragraph.  
6 Section 3. This act shall take effect in 60 days.
