AN ACT

1 Amending the act of August 26, 1971 (P.L.351, No.91), entitled
2 "An act providing for a State Lottery and administration
3 thereof; authorizing the creation of a State Lottery
4 Commission; prescribing its powers and duties; disposition of
5 funds; violations and penalties therefor; exemption of prizes
6 from State and local taxation and making an appropriation,"
7 further defining "maximum annual income" for purposes of
8 pharmaceutical assistance; and further providing for PACENET
9 eligibility.

10 The General Assembly of the Commonwealth of Pennsylvania
11 hereby enacts as follows:

12 Section 1. The definition of "maximum annual income" in
13 section 502 of the act of August 26, 1971 (P.L.351, No.91),
14 known as the State Lottery Law, added November 21, 1996
15 (P.L.741, No.134), is amended to read:

16 Section 502. Definitions.

17 The following words and phrases when used in this chapter
18 shall have the meanings given to them in this section unless the

1 context clearly indicates otherwise:

2 * * *

3 "Maximum annual income." For PACE eligibility, the term
4 shall mean annual income which shall not exceed \$14,000 in the
5 case of single persons nor \$17,200 in the case of the combined
6 annual income of persons married to each other, subject to an
7 increase beginning January 1, 2001, and annually thereafter by
8 the amount of the maximum Social Security benefit cost-of-living
9 increase for that year for single and married persons,
10 respectively. Persons may, in reporting income to the Department
11 of Aging, round the amount of each source of income and the
12 income total to the nearest whole dollar, whereby any amount
13 which is less than 50¢ is eliminated.

15 Section 2. Section 519(b) of the act, added November 21,
16 1996 (P.L.741, No.134), is amended to read:

17 Section 519. The Pharmaceutical Assistance Contract for the
18 Elderly Needs Enhancement Tier.

20 (b) PACENET eligibility.--A claimant with an annual income
21 of not less than \$14,000 and not more than \$16,000 in the case
22 of a single person and of not less than \$17,200 and not more
23 than \$19,200 in the case of the combined income of persons
24 married to each other, subject to an increase beginning January
25 1, 2001, and annually thereafter by the amount of the maximum
26 Social Security benefit cost-of-living increase for that year
27 for single and married persons, respectively, shall be eligible
28 for enhanced pharmaceutical assistance under this section. A
29 person may, in reporting income to the department, round the
30 amount of each source of income and the income total to the

1 nearest whole dollar, whereby any amount which is less than 50¢
2 is eliminated.

3 * * *

4 Section 3. This act shall be applied retroactively to
5 January 1, 2001.

6 Section 4. This act shall take effect immediately.
