                [A] Except as provided for in paragraph (1.1), a A <--

      person who violates subsection (a)(1) or (2) is guilty of a

first offense and upon conviction thereof shall be sentenced
to pay a fine of not less than {\$50} \$300 nor more than
[\$300] \$2,000 and be required to pick up litter or illegally
dumped trash for not less than five nor more than 30 hours to
be completed within six months, or to imprisonment for not
more than {90 days} one year, or both.

(1.1) A person who violates subsection (a) (1) or (2), in <-which the collective total weight of the discarded material
is less than one pound, is guilty of a summary offense for
the first offense and upon conviction thereof shall be
sentenced to pay a fine of not less than \$50 nor more than
\$300 or to imprisonment for not more than 90 days, or both.

- (2) A person who violates subsection (a)(1) or (2) is guilty of a misdemeanor of the {third} second degree for the <-second and subsequent offense and upon conviction thereof
 shall be sentenced to pay a fine of not less than {\$300} <-\$\frac{\$2,000}{2}\$ nor more than [\$1,000] \$5,000. The person also may be
 sentenced to imprisonment for not more than one year or be
 required to pick up litter or illegally dumped trash for not
 less than 30 nor more than 100 hours to be completed within
 {one year} two years. <--
- (3) A person who violates subsection (a) (3) is guilty of a misdemeanor of the second degree for the first offense and upon conviction thereof shall be sentenced to pay a fine of not less than \$500 nor more than [\$5,000] \$10,000. The person also may be sentenced to imprisonment or to performing a community service for a period not to exceed two years.
- (4) A person who violates subsection (a)(3) is guilty of a misdemeanor of the first degree for the second or

1 subsequent offense and upon conviction thereof shall be 2 sentenced to pay a fine of not less than \$1,000 nor more than 3 [\$10,000] \$20,000. The person also may be sentenced to imprisonment or to performing a community service for a 4 5 period not to exceed five years. 6 Section 2.
