## AN ACT

- 1 Amending the act of October 22, 1986 (P.L.1452, No.143),
- 2 entitled "An act expanding the available adult basic
- 3 education programs and the duties of the Department of
- 4 Education; making an appropriation; and making a partial
- 5 repeal," further providing for eligibility for adult literacy
- 6 education.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The definition of "eligible adult" in section 3
- 10 of the act of October 22, 1986 (P.L.1452, No.143), known as the
- 11 Adult Literacy Act, is amended to read:
- 12 Section 3. Definitions.
- 13 The following words and phrases when used in this act shall
- 14 have the meanings given to them in this section unless the
- 15 context clearly indicates otherwise:

- 2 "Eligible adult." A person who meets the following criteria:
- 3 (1) Is at least 17 years of age.
- 4 (2) Is a resident of this Commonwealth.
- 5 (3) [Does not hold a high school diploma or its
- 6 equivalent.
- 7 (4)] Is not currently enrolled in a public or private
- 8 secondary or postsecondary school.

- 10 SECTION 2. SECTION 4 OF THE ACT IS AMENDED TO READ:

- 11 SECTION 4. GRANT PROGRAM.
- 12 (A) ESTABLISHMENT.--THERE IS HEREBY ESTABLISHED WITHIN THE
- 13 DEPARTMENT AN ADULT LITERACY EDUCATION GRANT PROGRAM. ADULT
- 14 LITERACY EDUCATION PROVIDERS MAY APPLY TO THE DEPARTMENT FOR
- 15 GRANTS TO PROVIDE THE FOLLOWING SERVICES:
- 16 (1) ADULT LITERACY EDUCATION PROGRAMS, INCLUDING
- 17 SALARIES, WAGES, FRINGE BENEFITS, BOOKS AND OTHER
- 18 INSTRUCTIONAL MATERIALS.
- 19 (2) TRAINING FOR VOLUNTEER ADULT LITERACY EDUCATION
- 20 INSTRUCTORS.
- 21 (3) ADMINISTRATION OF ADULT LITERACY EDUCATION PROGRAMS.
- 22 (4) SUPPORT SERVICES NECESSARY TO ENABLE INDIVIDUALS TO
- 23 PARTICIPATE IN AND BENEFIT FROM THE PROGRAM.
- 24 (5) OUTREACH ACTIVITIES TO ENROLL ELIGIBLE ADULTS AND TO
- 25 RECRUIT VOLUNTEER TUTORS AND INSTRUCTORS.
- 26 (B) PROCEDURES, RULES AND FORMS.--THE SECRETARY SHALL ADOPT
- 27 SUCH PROCEDURES, RULES AND FORMS AS MAY BE NECESSARY TO
- 28 IMPLEMENT THIS GRANT PROGRAM. APPLICATIONS SHALL BE MADE TO THE
- 29 DEPARTMENT IN SUCH FORM AND AT SUCH TIME AS THE SECRETARY MAY
- 30 PRESCRIBE. FUNDS RECEIVED UNDER THIS PROGRAM MAY BE USED IN

- 1 CONJUNCTION WITH FUNDS RECEIVED FROM ANY OTHER PUBLIC OR PRIVATE
- 2 SOURCE.
- 3 (C) PRIORITIES FOR FUNDING.--THE SECRETARY SHALL CONSIDER,
- 4 BUT NOT BE LIMITED TO, THE FOLLOWING FACTORS WHEN EVALUATING
- 5 PROPOSALS FOR ADULT LITERACY EDUCATION PROGRAMS:
- 6 (1) [NUMBER] <u>PERCENTAGE</u> OF ELIGIBLE ADULTS EXPECTED TO
- 7 BE ENROLLED [IN CLASSES] FOR INSTRUCTION WHO ARE RECEIVING
- 8 EITHER STATE OR FEDERAL PUBLIC ASSISTANCE, OR WHO ARE
- 9 UNEMPLOYED WORKERS OR DISPLACED HOMEMAKERS.
- 10 (2) [NUMBER] <u>PERCENTAGE</u> OF ELIGIBLE ADULTS IN ANY LOCAL
- 11 AREA WHO DO NOT HAVE CERTIFICATES OF GRADUATION FROM A
- 12 SECONDARY SCHOOL AND WHO ARE NOT CURRENTLY ENROLLED IN ADULT
- 13 LITERACY EDUCATION PROGRAMS.
- 14 (3) [NUMBER] PERCENTAGE OF ELIGIBLE ADULTS EXPECTED TO
- 15 BE ENROLLED WHO ARE MEMBERS OF MINORITY GROUPS.
- 16 (4) [NUMBER] <u>PERCENTAGE</u> OF ELIGIBLE ADULTS WITH LESS
- 17 THAN A FIFTH GRADE READING LEVEL TO BE SERVED.
- 18 [(5) THE PROVISION OF CLIENT OUTREACH AND REFERRAL
- 19 ACTIVITIES THAT ARE COORDINATED WITH OTHER ADULT EDUCATION
- 20 AND LITERACY PROGRAMS, COUNTY ASSISTANCE OFFICES, SOCIAL
- 21 SERVICE AGENCIES, OFFICES OF EMPLOYMENT SECURITY, JOB
- 22 TRAINING PARTNERSHIP ACT PROGRAMS AND OTHER COMMUNITY GROUPS
- 23 OR AGENCIES THAT PROVIDE SERVICES AND ASSISTANCE TO PERSONS
- 24 IN NEED OF BASIC LITERACY SKILLS.]
- 25 SECTION 3. THE ACT IS AMENDED BY ADDING A SECTION TO READ:
- 26 <u>SECTION 4.1. DUTY OF DEPARTMENT.</u>
- 27 THE DEPARTMENT SHALL PROVIDE CLIENT OUTREACH AND REFERRAL
- 28 ACTIVITIES THAT ARE COORDINATED WITH OTHER ADULT EDUCATION AND
- 29 <u>LITERACY PROGRAMS, COUNTY ASSISTANCE OFFICES, SOCIAL SERVICE</u>
- 30 AGENCIES, OFFICES OF EMPLOYMENT SECURITY, JOB TRAINING
