AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, providing 5 for administration of epinephrine auto-injectors by school 6 bus drivers AND SCHOOL CROSSING GUARDS. <--8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 11 as the Public School Code of 1949, is amended by adding a 12 section to read: 13 Section 1414.9. Administration of Epinephrine Auto-injectors 14 by School Bus Drivers AND SCHOOL CROSSING GUARDS. -- The <--15 provisions of 42 Pa.C.S. §§ 8332 (relating to emergency response

provider and bystander good Samaritan civil immunity) and 8337.1

(relating to civil immunity of school officers or employees

- 1 relating to emergency care, first aid and rescue) shall apply to
- 2 a school bus driver AND A SCHOOL CROSSING GUARD when all of the <--
- 3 following apply:
- 4 (1) The school bus driver OR SCHOOL CROSSING GUARD <--
- 5 <u>administers an epinephrine auto-injector to a student in a</u>
- 6 manner consistent with the policies established by all of the
- 7 <u>following:</u>
- 8 (i) the independent contractor that employs the school bus
- 9 <u>driver OR SCHOOL CROSSING GUARD</u>, if the school bus driver OR <
- 10 SCHOOL CROSSING GUARD is employed by an independent contractor;
- 11 (ii) the school entity that has contracted with the
- 12 <u>independent contractor</u>, if the school bus driver OR SCHOOL <--
- 13 CROSSING GUARD is employed by an independent contractor; and
- 14 (iii) the school entity that employs the school bus driver
- 15 OR SCHOOL CROSSING GUARD, if the school bus driver OR SCHOOL <--
- 16 CROSSING GUARD is employed by a school entity.
- 17 (2) The school bus driver OR SCHOOL CROSSING GUARD has <--
- 18 successfully completed a training program that shall be
- 19 developed and implemented by the Department of Health. The
- 20 Department of Health shall have ninety (90) days from the
- 21 effective date of this section to develop and implement such a
- 22 training program.
- 23 Section 2. This act shall take effect in 60 days.
