- 2 Class Aaron M. Genevie, who died on April 16, 2007, from
- wounds sustained when his Humvee struck an improvised
- 4 explosive device while he was courageously serving our nation
- 5 in Iraq.
- 6 WHEREAS, Private First Class Aaron M. Genevie of Chambersburg
- 7 died when his Humvee hit an improvised explosive device in
- 8 Baghdad, Iraq, on April 16, 2007; and

- 1 WHEREAS, Pfc. Genevie paid the supreme sacrifice for his
- 2 nation in Operation Iraqi Freedom; and
- 3 WHEREAS, A 2003 graduate of McConnellsburg High School, Pfc.
- 4 Genevie had served in the Army since July 2005; and
- 5 WHEREAS, An assigned member of Troop B, 1st Squadron, 4th
- 6 Cavalry Regiment, 4th Infantry Brigade Combat Team, 1st Infantry
- 7 Division, based in Fort Riley, Kansas, Pfc. Genevie had been in
- 8 Iraq for two months on his first deployment; and
- 9 WHEREAS, Pfc. Genevie has been awarded the Purple Heart and
- 10 the Bronze Star Medal and is buried at Arlington National
- 11 Cemetery; and
- 12 WHEREAS, Pfc. Genevie is survived by his mother, Patricia
- 13 Genevie, and by his father, Girard Genevie, as well as numerous
- 14 friends; and
- WHEREAS, The House of Representatives wishes to posthumously
- 16 honor Pfc. Genevie for his courageous service to our nation;
- 17 therefore be it
- 18 RESOLVED, That the House of Representatives recognize with
- 19 sadness the supreme sacrifice of Private First Class Aaron M.
- 20 Genevie, who died on April 16, 2007, while courageously serving
- 21 our nation in Iraq; and be it further
