AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, in judicial computer
- 3 system, further providing for utilization of funds in account
- and for surcharge; and repealing annual appropriations
- 5 provisions.
- The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 3732(a) of Title 42 of the Pennsylvania
- 9 Consolidated Statutes is amended and the section is amended by
- 10 adding a subsection to read:
- 11 § 3732. Utilization of funds in account.
- 12 (a) General rule. -- Except [for the repayments under
- 13 subsection (b)] as set forth under subsections (b) and (c), all
- 14 moneys deposited into the Judicial Computer System Augmentation
- 15 Account shall be used only for the initial startup and the
- 16 ongoing operations of the Statewide judicial computer system.
- 17 * * *
- 18 (c) Cadet classes. -- Notwithstanding any other provision of
- 19 law to the contrary, all moneys deposited into the Judicial

- 1 Computer System Augmentation Account shall be transferred to the
- 2 Pennsylvania State Police for cadet classes.
- 3 Section 2. Section 3733.1(c) of Title 42, amended July 9,
- 4 2014 (P.L.1004, No.113), is amended to read:
- 5 § 3733.1. Surcharge.
- 6 * * *
- 7 (c) Allocation and appropriation.--
- 8 (1) The surcharge under subsection (a) (1) shall be
- 9 deposited into [a separate reserve account within] the
- 10 Judicial Computer System Augmentation Account.
- 11 [Notwithstanding section 3732 (relating to utilization of
- 12 funds in account), money deposited under this paragraph is
- hereby appropriated to the Supreme Court, upon compliance
- with Article XV of the act of April 9, 1929 (P.L.343,
- No.176), known as The Fiscal Code, for the operation of the
- 16 Judicial Department.]
- 17 (2) The fee under subsection (a) (2) shall be deposited
- into the Criminal Justice Enhancement Account.
- 19 (3) The fee under subsection (a) (3) shall be deposited
- 20 into the Access to Justice Account.
- 21 Section 3. Section 3734 of Title 42 is repealed:
- 22 [§ 3734. Annual appropriations.
- 23 Beginning with the fiscal year 1987-1988, the General
- 24 Assembly shall appropriate initially from the General Fund and
- 25 thereafter from the Judicial Computer System Augmentation
- 26 Account funds sufficient to meet the costs of the initial
- 27 startup and the ongoing operations of the Statewide judicial
- 28 computer system.]
- 29 Section 4. The amendment, addition or repeal of 42 Pa.C.S.
- 30 §§ 3732(a) and (c), 3733.1(c) and 3734 shall apply to money

- 1 deposited into the Judicial Computer System Augmentation Account
- 2 on or after July 1, 2015.
- 3 Section 5. This act shall take effect immediately.
