## AN ACT

- Amending Title 42 (Judiciary and Judicial Procedure) of the 2 Pennsylvania Consolidated Statutes, further providing for the 3 commencement of certain prosecutions; AND PROVIDING FOR LIABILITY OF DONOR FOR DAMAGES RESULTING FROM THE CONDITION OF AND COLLECTION OF DONATED FOOD. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 5551 of Title 42 of the Pennsylvania Consolidated Statutes is amended to read: 10 § 5551. No limitation applicable. A prosecution for the following offenses may be commenced at 11 12 any time: 13 (1) Murder.

- 6 (5) A violation of 75 Pa.C.S. § 3742 (relating to
- 7 <u>accidents involving death or personal injury</u>) and either 75
- 8 Pa.C.S. § 3732 (relating to homicide by vehicle) or 18
- 9 <u>Pa.C.S. § 2504 (relating to involuntary manslaughter)</u> if the
- 10 accused was the driver of a vehicle involved in an accident
- resulting in the death of any person.
- 12 SECTION 2. TITLE 42 IS AMENDED BY ADDING A SECTION TO READ:

- 13 § 8338. LIABILITY FOR DAMAGES FROM DONATED FOOD AND GROCERY
- 14 PRODUCTS.
- 15 (A) GENERAL RULE. -- A PERSON IS NOT SUBJECT TO CIVIL OR
- 16 CRIMINAL LIABILITY ARISING FROM THE NATURE, AGE, PACKAGING OR
- 17 CONDITION OF APPARENTLY WHOLESOME FOOD OR OF GROCERY PRODUCTS
- 18 APPARENTLY FIT FOR HOUSEHOLD CONSUMPTION OR USE THAT THE PERSON
- 19 DONATED IN GOOD FAITH TO A NONPROFIT ORGANIZATION FOR ULTIMATE
- 20 FREE DISTRIBUTION TO NEEDY INDIVIDUALS. THIS SECTION DOES NOT
- 21 APPLY TO AN INJURY OR DEATH OF THE ULTIMATE USERS OR RECIPIENTS
- 22 OF THE FOOD OR GROCERY PRODUCTS THAT RESULTS FROM AN ACT OR
- 23 OMISSION OF THE DONOR CONSTITUTING GROSS NEGLIGENCE,
- 24 RECKLESSNESS OR INTENTIONAL MISCONDUCT.
- 25 <u>(B) RECKLESSNESS, GROSS NEGLIGENCE OR INTENTIONAL</u>
- 26 MISCONDUCT. -- A PERSON WHO PERMITS GLEANING ON PROPERTY OWNED OR
- 27 OCCUPIED BY HIM IS NOT SUBJECT TO CIVIL OR CRIMINAL LIABILITY
- 28 THAT ARISES DUE TO THE INJURY OR DEATH OF ANY INDIVIDUAL
- 29 INVOLVED IN THE COLLECTION OR GLEANING OF DONATIONS, UNLESS THE
- 30 <u>INJURY OR DEATH RESULTS FROM AN ACT OR OMISSION OF SAID PERSON</u>

- 1 CONSTITUTING GROSS NEGLIGENCE, RECKLESSNESS OR INTENTIONAL
- 2 <u>MISCONDUCT</u>.
- 3 (C) NONLIABILITY. -- THIS SECTION DOES NOT CREATE ANY
- 4 LIABILITY.
- 5 (D) DEFINITIONS.--AS USED IN THIS SECTION, THE FOLLOWING
- 6 WORDS AND PHRASES SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS
- 7 SUBSECTION:
- 8 <u>"DONATE." TO GIVE OR DISTRIBUTE WITHOUT REQUIRING ANYTHING</u>
- 9 OF MONETARY VALUE FROM THE ULTIMATE RECIPIENT. FOR PURPOSES OF
- 10 THIS SECTION, A NONPROFIT ORGANIZATION MAY DONATE TO ANOTHER
- 11 NONPROFIT ORGANIZATION, NOTWITHSTANDING THAT THE DONOR
- 12 ORGANIZATION HAS CHARGED A PROCESSING FEE TO THE DONEE
- 13 ORGANIZATION, PROVIDED THE ULTIMATE RECIPIENT OR USER IS NOT
- 14 REQUIRED TO GIVE ANYTHING OF MONETARY VALUE.
- 15 "GLEAN." TO HARVEST FOR ULTIMATE FREE DISTRIBUTION TO NEEDY
- 16 <u>INDIVIDUALS AN AGRICULTURAL CROP THAT HAS BEEN DONATED BY ANY</u>
- 17 PERSON.
- 18 "GROCERY PRODUCTS." ANY NON-FOOD GROCERY PRODUCTS,
- 19 INCLUDING, BUT NOT LIMITED TO, DISPOSABLE PAPER AND PLASTIC
- 20 PRODUCTS, HOUSEHOLD CLEANING PRODUCTS, BOTTLED WATER, LAUNDRY
- 21 DETERGENTS AND CLEANING PRODUCTS AND MISCELLANEOUS HOUSEHOLD
- 22 ITEMS.
- 23 "NONPROFIT ORGANIZATION." AN INCORPORATED OR UNINCORPORATED
- 24 ORGANIZATION THAT HAS BEEN INCORPORATED OR ESTABLISHED AND IS
- 25 OPERATING FOR RELIGIOUS, CHARITABLE, OR EDUCATION PURPOSES AND
- 26 THAT DOES NOT DISTRIBUTE ANY OF ITS INCOME TO ITS MEMBERS,
- 27 DIRECTORS OR OFFICERS.
- 28 "PERSON." ANY INDIVIDUAL, CORPORATION, PARTNERSHIP,
- 29 ORGANIZATION, ASSOCIATION, OR GOVERNMENT ENTITY, INCLUDING, BUT
- 30 NOT LIMITED TO, RETAIL GROCERS, WHOLESALERS, MANUFACTURERS,

- 1 RESTAURANTS, CATERERS, FARMERS, NONPROFIT FOOD DISTRIBUTORS AND
- 2 HOSPITALS. IN THE CASE OF A CORPORATION, PARTNERSHIP,
- 3 ORGANIZATION, ASSOCIATION OR GOVERNMENTAL ENTITY, THE TERM ALSO
- 4 <u>INCLUDES</u>, <u>BUT IS NOT LIMITED TO</u>, <u>THE OFFICERS</u>, <u>DIRECTORS</u>,
- 5 PARTNERS, DEACONS, TRUSTEES, COUNCIL MEMBERS OR OTHER ELECTED OR
- 6 APPOINTED INDIVIDUALS RESPONSIBLE FOR THE GOVERNANCE OF SUCH
- 7 ENTITY.
- Section  $\frac{2}{3}$ . This act shall take effect in 60 days. 8
