INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, OCTOBER 21, 2015

A RESOLUTION

- 1 Recognizing the month of October 2015 as "National Medicine 2 Abuse Awareness Month" in Pennsylvania.
- 3 WHEREAS, Over-the-counter and prescription medicines approved
- 4 by the Food and Drug Administration have been determined to be
- 5 safe and effective when used properly; and
- 6 WHEREAS, The misuse or abuse of these medicines can be
- 7 extremely dangerous and produce serious side effects; and
- 8 WHEREAS, The Office of National Drug Control Policy reports
- 9 that medicine abuse is the fastest-growing drug problem in the
- 10 United States, and the Centers for Disease Control and
- 11 Prevention (CDC) has classified medicine abuse as an epidemic;
- 12 and
- 13 WHEREAS, According to a report by the Trust for America's

- 1 Health (TFAH), prescription drug abuse has quickly become a top
- 2 public health concern, as prescription drug-related deaths now
- 3 outnumber those from heroin and cocaine combined, and drug
- 4 overdose deaths exceed motor vehicle-related deaths in 29
- 5 states; and
- 6 WHEREAS, The United States Substance Abuse and Mental Health
- 7 Services Administration's 2012 National Survey on Drug Use and
- 8 Health found that over the past decade, the nonmedical use of
- 9 prescription drugs among persons 12 years of age or older rose
- 10 from 1.9 million in 2002 to 11.1 million in 2011; and
- 11 WHEREAS, According to the CDC, nationally, sales of
- 12 prescription painkillers per capita have quadrupled since 1999,
- 13 and the number of fatal poisonings due to prescription
- 14 painkillers has also quadrupled; and
- 15 WHEREAS, According to the Johns Hopkins Center for Injury
- 16 Research and Policy, 50 Americans die each day from prescription
- 17 drug overdoses and more than 6 million suffer from prescription
- 18 drug abuse disorders; and
- 19 WHEREAS, Pennsylvania has the 14th highest drug overdose
- 20 mortality rate in the United States, with 15.3 per 100,000
- 21 people suffering drug overdose fatalities, according to a new
- 22 TFAH report, Prescription Drug Abuse: Strategies to Stop the
- 23 Epidemic; and
- 24 WHEREAS, In view of this, a nationwide prevention and
- 25 education campaign has been launched by the Community Anti-Drug
- 26 Coalitions of America, a national organization that represents
- 27 5,000 antidrug coalitions nationwide, along with the Consumer
- 28 Healthcare Products Association, to provide local coalitions
- 29 with tools, training and outreach strategies to engage and
- 30 educate parents, grandparents, teachers, law enforcement

- 1 officials, retailers, doctors and other health care
- 2 professionals about the potential harms of over-the-counter
- 3 medicine abuse; and
- 4 WHEREAS, In addition, the Drug Enforcement Administration and
- 5 many State and local law enforcement agencies have established
- 6 drug disposal programs, commonly referred to as take-back
- 7 programs, to facilitate the collection and destruction of
- 8 unused, unwanted or expired medications, thereby helping to take
- 9 outdated or unused medications off household shelves and out of
- 10 the reach of children and teenagers; and
- 11 WHEREAS, "National Medicine Abuse Awareness Month" promotes
- 12 the message that over-the-counter and prescription medicines are
- 13 to be taken only as labeled or prescribed and that using such
- 14 medicines to "get high" or in large doses can cause serious or
- 15 life-threatening consequences; and
- 16 WHEREAS, Observance of "National Medicine Abuse Awareness
- 17 Month" should be encouraged at the national, state and local
- 18 levels to increase awareness of the abuse of medicines; and
- 19 WHEREAS, Educating the public about the dangers of medicine
- 20 abuse, encouraging parents to talk about medicine abuse with
- 21 their teenagers, mobilizing parents to safeguard their home
- 22 medicine cabinets and promoting abuse prevention are critical
- 23 components of what must be a multipronged effort to curb over-
- 24 the-counter and prescription medicine abuse; therefore be it
- 25 RESOLVED, That the House of Representatives recognize the
- 26 month of October 2015 as "National Medicine Abuse Awareness
- 27 Month" in Pennsylvania and urge communities to carry out
- 28 appropriate programs and activities to educate parents and
- 29 youths of the potential dangers associated with medicine abuse.
