AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, defining the offense of graffiti
- 3 mischief; and providing penalties.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 18 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 3310. Graffiti mischief.
- 9 (a) Offense defined. -- A person commits graffiti mischief if
- 10 he damages the tangible property of another intentionally,
- 11 recklessly or by negligence through the application of any
- 12 paint, marking or other substance.
- 13 (b) Grading.--Graffiti mischief is a felony of the first
- 14 degree punishable by a fine of \$5,000 if the actor intentionally
- 15 causes pecuniary loss in excess of \$1,000, a felony of the
- 16 second degree punishable by a fine of \$2,500 if the actor
- 17 intentionally causes pecuniary loss in excess of \$500, or a
- 18 felony of the third degree punishable by a fine of \$1,000 if he

- 1 intentionally or recklessly causes pecuniary loss in excess of
- 2 \$200. Otherwise, graffiti mischief is a misdemeanor of the first
- 3 <u>degree</u>.
- 4 (c) Parent or quardian responsible. -- The parent or quardian
- 5 of any minor convicted under this section shall be liable for
- 6 the amount of any fine imposed by the court.
- 7 (d) Restitution. -- The court shall order a defendant
- 8 convicted under this section to make restitution to the victim.
- 9 (e) Publication. -- The court shall publish, in the Sunday
- 10 edition of any newspaper of general circulation within the
- 11 county, the name of any person convicted under this section.
- 12 (f) Definitions.--As used in this section, the following
- 13 words and phrases shall have the meanings given to them in this
- 14 subsection:
- 15 "Indelible marker." Any felt tip marker, china marker or
- 16 <u>similar device which applies a substance which is not water</u>
- 17 soluble.
- 18 "Paint, marking or other substance." Any adherent, pigmented
- 19 substance which is not water soluble and which is applied as
- 20 spray paint or by indelible marker or otherwise.
- 21 "Spray paint." Any adherent, pigmented substance dispersed
- 22 in particles by means of an atomizer or other simple mechanical
- 23 instrument or applicator.
- 24 Section 2. This act shall take effect immediately.
