INTRODUCED BY EVANS, MARCH 12, 1991

AS AMENDED ON THIRD CONSIDERATION, HOUSE OF REPRESENTATIVES,  
MARCH 19, 1991

## AN ACT

1 Amending the act of July 1, 1990 (P.L. , No.7A), entitled "An  
2 act to provide from the General Fund for the expenses of the  
3 Executive, Legislative and Judicial Departments of the  
4 Commonwealth, the public debt and for the public schools for  
5 the fiscal year July 1, 1990, to June 30, 1991, and for the  
6 payment of bills incurred and remaining unpaid at the close  
7 of the fiscal year ending June 30, 1990; to provide  
8 appropriations from the State Lottery Fund, the Pennsylvania  
9 Economic Revitalization Fund, the Energy Conservation and  
10 Assistance Fund, The State Stores Fund and the Emergency  
11 Medical Services Operating Fund to the Executive Department;  
12 to provide appropriations from the Judicial Computer System  
13 Augmentation Account to the Judicial Department; to provide  
14 appropriations from the Motor License Fund for the fiscal  
15 year July 1, 1990, to June 30, 1991, for the proper operation  
16 of the several departments of the Commonwealth and the  
17 Pennsylvania State Police authorized to spend Motor License  
18 Fund moneys; and to provide for the appropriation of Federal  
19 funds to the Executive and Judicial Departments of the  
20 Commonwealth and for the establishment of restricted receipts  
21 accounts for the fiscal year July 1, 1990, to June 30, 1991,  
22 and for the payment of bills incurred and remaining unpaid at  
23 the close of the fiscal year ending June 30, 1990," providing  
24 additional Federal appropriations.

25 The General Assembly of the Commonwealth of Pennsylvania  
26 hereby enacts as follows:

27 Section 1. As much of the Federal appropriations for medical  
28 assistance in section 219 of the act of July 1, 1990 (P.L. ,

1 No.7A), known as the General Appropriation Act of 1990, are  
2 amended to read:
