AN ACT

Amending the act of July 31, 1968 (P.L.805, No.247), entitled, 2 as amended, "An act to empower cities of the second class A, 3 and third class, boroughs, incorporated towns, townships of the first and second classes including those within a county of the second class and counties of the second through eighth classes, individually or jointly, to plan their development 7 and to govern the same by zoning, subdivision and land development ordinances, planned residential development and 9 other ordinances, by official maps, by the reservation of certain land for future public purpose and by the acquisition 10 of such land; to promote the conservation of energy through 11 12 the use of planning practices and to promote the effective 13 utilization of renewable energy sources; providing for the 14 establishment of planning commissions, planning departments, 15 planning committees and zoning hearing boards, authorizing them to charge fees, make inspections and hold public 16 17 hearings; providing for mediation; providing for transferable 18 development rights; providing for appropriations, appeals to 19 courts and penalties for violations; and repealing acts and parts of acts," further providing for appointment, term and 20 vacancy of planning commission members and for conduct of 21 22 business of planning commission.

- 23 The General Assembly of the Commonwealth of Pennsylvania
- 24 hereby enacts as follows:
- 25 Section 1. Section 203 of the act of July 31, 1968 (P.L.805,

- 1 No.247), known as the Pennsylvania Municipalities Planning Code,
- 2 reenacted and amended December 21, 1988 (P.L.1329, No.170), is
- 3 amended by adding a subsection to read:
- 4 Section 203. Appointment, Term and Vacancy. -- * *
- 5 (e) The governing body may appoint by resolution at least
- 6 one but no more than three residents of the municipality to
- 7 <u>serve as alternate members of the planning commission. The term</u>
- 8 of office of an alternate member shall be three FOUR years. When <-
- 9 <u>seated pursuant to the provisions of section 207, an alternate</u>
- 10 shall be entitled to participate in all proceedings and
- 11 discussions of the commission to the same and full extent as
- 12 provided by law for commission members, including specifically
- 13 the right to cast a vote as a voting member during the
- 14 proceedings, and shall have all the powers and duties set forth
- 15 <u>in this act and as otherwise provided by law. Alternates shall</u>
- 16 <u>hold no other elected or appointed office in the municipality</u>,
- 17 including service NOT SERVE as a member of the zoning hearing

- 18 board or as a zoning officer, nor shall any alternate be an
- 19 employee of the municipality. Any alternate may participate in
- 20 any proceeding or discussion of the commission but shall not be
- 21 <u>entitled to vote as a member of the commission nor be reimbursed</u>
- 22 pursuant to section 202 unless designated as a voting alternate
- 23 member pursuant to section 207.
- 24 Section 2. Section 207 of the act is amended to read:
- 25 Section 207. Conduct of Business.--(a) The commission shall
- 26 elect its own chairman and vice-chairman and create and fill
- 27 such other offices as it may determine. Officers shall serve
- 28 annual terms and may succeed themselves. The commission may make
- 29 and alter by laws and rules and regulations to govern its
- 30 procedures consistent with the ordinances of the municipality

- 1 and the laws of the Commonwealth. The commission shall keep a
- 2 full record of its business and shall annually make a written
- 3 report by March 1 of each year of its activities to the
- 4 governing body. Interim reports may be made as often as may be
- 5 necessary, or as requested by the governing body.
- 6 (b) The chairman of the planning commission may designate
- 7 <u>alternate members of the commission to replace any absent or</u>
- 8 disqualified member SUBSTITUTE FOR ANY ABSENT MEMBER OR MEMBER <-
- 9 WHO HAS RECUSED HIMSELF OR HAS BEEN DISQUALIFIED BY THE
- 10 GOVERNING BODY, and if, by reason of absence or, recusal or
- 11 <u>disqualification of a member, a quorum is not reached, the</u>
- 12 <u>chairman of the commission shall designate as many alternate</u>
- 13 members of the commission to sit on the commission as may be
- 14 needed to reach a quorum. Any alternate member of the commission
- 15 <u>shall continue to serve on the commission in all proceedings</u>
- 16 <u>involving the matter or case for which the alternate was</u>
- 17 <u>initially appointed until the commission has made a final</u>
- 18 decision on the matter or case. Designation of an alternate
- 19 pursuant to this section shall be made on a case-by-case basis
- 20 <u>in rotation according to declining seniority among all</u>
- 21 alternates.
- 22 Section 3. This act shall take effect in 60 days.
