AN ACT

- 1 Amending the act of May 18, 1945 (P.L.809, No.323), entitled "An
- act removing certain roads or sections of road from the State
- 3 highway system; and providing for their future maintenance
- 4 and construction, " removing a route in Union County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 1, act of May 18, 1945 (P.L.809, No.323),
- 8 entitled "An act removing certain roads or sections of road from
- 9 the State highway system; and providing for their future
- 10 maintenance and construction, "introductory paragraph amended
- 11 July 9, 1976 (P.L.972, No.193), is amended by removing the
- 12 following route:
- 13 Section 1. The following described roads, or parts of roads,
- 14 which were added to the State highway system under the
- 15 provisions of the act, approved the twenty-seventh day of April,
- 16 one thousand nine hundred twenty-seven (Pamphlet Laws 409,
- 17 No.266), entitled "An act authorizing the Secretary of Highways
- 18 to join two or more State highway routes, by the construction of
- 19 connecting roads, under certain conditions, and providing for

- 1 the payment of damages for land taken in the construction of
- 2 such connecting roads, " or under the provisions of section 217
- 3 or section 220 of the act, approved the first day of June, one
- 4 thousand nine hundred forty-five (Pamphlet Laws 1242, No.428),
- 5 known as the "State Highway Law," and which have been numbered
- 6 by the Secretary of Highways, as indicated, are hereby removed
- 7 from the said system.

- 9 UNION COUNTY

- Route 59044, Spur E. Beginning at a point on Route 24 in East
- 12 <u>Buffalo Township at Station 274+45 of Route 24 and proceeding in</u>
- 13 <u>a northeasterly direction to Station 20+60 on the Lewisburg</u>
- 14 Borough Line, then northwesterly along Seventh Street to Station
- 15 800+45 on Route 26, in Union County, a distance of about 0.7920
- 16 miles.
- 17 Section 2. On and after the effective date of this act, the
- 18 road herein described shall be maintained, constructed and
- 19 reconstructed by the authorities of the township and borough in
- 20 which it is located.
- 21 Section 3. This act shall take effect immediately.
