AN ACT

- 1 Requiring the affixing of a nameplate listing energy consumption
- 2 information and a paper tag indicating average annual
- 3 operating cost of certain electrical appliances before they
- 4 are sold or offered for sale and providing penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. As used in this act:
- 8 "Casual sale" means an isolated sale of an electrical
- 9 appliance by a person who is not regularly engaged in the
- 10 business of making such sales and where such appliance was
- 11 obtained by the person making the sale for his own use.
- 12 "Electrical appliance" means any commercial mechanism which
- 13 is operated by electric current in or about the home, including
- 14 but not limited to, cooking equipment, heating devices,
- 15 refrigeration, air conditioners, electric fans, clocks, radios,
- 16 toasters, irons, television sets, vacuum cleaners, washing
- 17 machines, driers, dishwashers, and coffee pots.
- 18 Section 2. (a) No person shall manufacture, sell, attempt to
- 19 sell or offer for sale, whether it be by retail, wholesale or by

- 1 auction, any electrical appliance unless there is permanently
- 2 affixed thereto a nameplate which shall have at least the
- 3 following information, printed in clearly legible type:
- 4 (1) The name and address of the manufacturer.
- 5 (2) The country of manufacture.
- 6 (3) The model number.
- 7 (4) The required operating voltage.
- 8 (5) The amperage and wattage used at the voltage.
- 9 (b) The information required by this section may be molded,
- 10 cast or impressed into the external surface of the body, shell
- 11 or base of the electrical appliance.
- 12 Section 3. No person shall manufacture, sell, attempt to
- 13 sell or offer for sale, whether it be by retail, wholesale or by
- 14 auction, any electrical appliance to which is not affixed
- 15 thereto a tag bearing the following in clearly legible type:
- 16 "The cost of operating this appliance over its lifetime
- 17 should be considered in making the best purchase. Electrical
- 18 costs vary, but, based on 4c per kilowatt an hour, average use
- 19 of this appliance at maximum setting will cost \$..... per
- 20 year. Your wise use of this appliance can reduce this cost." The
- 21 manufacturer shall be responsible for determining the cost and
- 22 may employ the services of any outside agency approved by the
- 23 Department of Justice for said purpose.
- 24 Section 4. Any advertisement of the sale of electrical
- 25 appliances shall contain the information required pursuant to
- 26 sections 2 and 3 with the exception of the model number
- 27 requirement in section 2(a)(3).
- 28 Section 5. (a) Whenever it shall appear to the Attorney
- 29 General or his designee that a person has engaged in, is
- 30 engaging in or is about to engage in any practice in violation

- 1 of this act he may seek and obtain an injunction prohibiting the
- 2 person from continuing those practices or engaging therein or
- 3 doing any acts in furtherance thereof.
- 4 (b) The provisions of this act shall not apply to casual
- 5 sales.
- 6 Section 6. Any person who violates this act shall be
- 7 sentenced to pay a fine of \$100 for the first offense and \$250
- 8 for any subsequent offense.
- 9 Section 7. The Department of Justice may make rules and
- 10 regulations to carry out the purposes of this act.
- 11 Section 8. This act shall take effect in six months.
