AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, further providing for special speed limitations.

3 The General Assembly of the Commonwealth of Pennsylvania
4 hereby enacts as follows:

5 Section 1. Section 3365(d) of Title 75 of the Pennsylvania
6 Consolidated Statutes is amended to read:

7 § 3365. Special speed limitations.

8 * * *

9 [(d) Penalty.--Any person violating any provision of this
10 section is guilty of]

11 (d) Penalty.--

12 (1) Any person who violates subsection (a), (c) or (c.1)
13 commits a summary offense and shall, upon conviction, be
14 sentenced to pay a fine of \$35. Any person exceeding a
15 maximum speed limit established under [this section]
16 subsection (a), (c) or (c.1) by more than five miles per hour

1 shall pay an additional fine of \$2 per mile for each mile in
2 excess of five miles per hour in excess of the maximum speed
3 limit.

4 (2) Any person who violates subsection (b) commits a
5 summary offense and shall, upon conviction, be sentenced as
6 follows:

7 (i) For a first conviction, pay a fine of \$50. Any
8 person exceeding a maximum speed limit established under
9 subsection (b) by more than five miles per hour shall pay
10 an additional fine of \$2 per mile for each mile in excess
11 of five miles per hour in excess of the maximum speed
12 limit.

13 (ii) For a second conviction, pay a fine of \$100.
14 Any person exceeding a maximum speed limit established
15 under subsection (b) by more than five miles per hour
16 shall pay an additional fine of \$2 per mile for each mile
17 in excess of five miles per hour in excess of the maximum
18 speed limit. In addition, the court, including a court
19 not of record if it is exercising jurisdiction pursuant
20 to 42 Pa.C.S. § 1515(a) (relating to jurisdiction and
21 venue), shall order the operating privilege of the person
22 suspended for a period of 60 days. A copy of the order
23 shall be transmitted to the department.

24 (iii) For a third and subsequent conviction, pay a
25 fine of \$250. Any person exceeding a maximum speed limit
26 established under subsection (b) by more than five miles
27 per hour shall pay an additional fine of \$2 per mile for
28 each mile in excess of five miles per hour in excess of
29 the maximum speed limit. In addition, the court,
30 including a court not of record if it is exercising

1 jurisdiction pursuant to 42 Pa.C.S. § 1515(a), shall
2 order the operating privilege of the person suspended for
3 a period of three months. A copy of the order shall be
4 transmitted to the department.

5 Section 2. This act shall take effect in 60 days.
