AN ACT

- 1 Providing for the registration of commercial house inspectors
- and for additional powers and duties of the Department of
- 3 Labor and Industry; and providing for rules and regulations
- 4 and for penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Commercial
- 9 House Inspectors Registration Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Commercial house inspector." A person, firm or corporation
- 15 which is contracted to inspect or supervise the inspection of
- 16 the house of another. An inspection shall include, but not be
- 17 limited to, the house's structural support, foundation and roof,
- 18 as well as the electrical, plumbing and heating systems.

- 1 "Department." The Department of Labor and Industry of the
- 2 Commonwealth.
- 3 Section 3. Registration required.
- 4 No person shall conduct an inspection or supervise an
- 5 inspection of the house of another unless that person is a
- 6 commercial house inspector registered with the department.
- 7 Section 4. Requirements for registration and issuance of
- 8 certificate.
- 9 (a) Requirements. -- An applicant for registration under this
- 10 act must submit written proof to the department that the
- 11 applicant:
- 12 (1) Has successfully completed the certification process
- 13 utilized by the American Society of Home Inspectors.
- 14 (2) Has obtained insurance against liability and errors
- and omissions in an amount determined to be sufficient by the
- 16 department.
- 17 (b) Issuance of registration certificate. -- The department
- 18 shall issue a registration certificate to the commercial house
- 19 inspector if the requirements of subsection (a) are met.
- 20 Section 5. Duration of registration.
- 21 Each registration shall be valid for one year from the date
- 22 it is issued unless otherwise revoked. All registrations must be
- 23 renewed annually on forms provided by the department.
- 24 Section 6. Fee for registration.
- 25 Fees for registrations under this act shall be determined by
- 26 the department and shall be used for costs incurred in the
- 27 administration of this act.
- 28 Section 7. Penalties.
- 29 Any person, firm or corporation that engages in the business
- 30 or occupation of or advertises or holds itself out as or acts

- 1 temporarily or otherwise as a commercial house inspector without
- 2 first having secured the required registration under this act,
- 3 or who otherwise violates this act, shall, upon conviction, be
- 4 sentenced to pay a fine of not less than \$500 nor more than
- 5 \$5,000, or to imprisonment for not more than 30 days, or both.
- 6 Each day a violation continues shall be a separate offense.
- 7 Section 8. Effective date.
- 8 This act shall take effect in 90 days.
