AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- 2 act to consolidate, editorially revise, and codify the public
- 3 welfare laws of the Commonwealth, " further providing for
- 4 applications for assistance.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 431 of the act of June 13, 1967 (P.L.31,
- 8 No.21), known as the Public Welfare Code, amended July 31, 1968
- 9 (P.L.904, No.273), is amended to read:
- 10 Section 431. Application. -- (a) Every person applying for
- 11 public assistance shall be required to sign a statement setting
- 12 forth his financial status and such other facts as may be
- 13 required by the department, in order to determine whether such
- 14 person is entitled to public assistance. Every such applicant
- 15 shall make affidavit that the facts set forth in such statement

- 1 are true and correct. Every person employed in the
- 2 administration of public assistance shall have power to
- 3 administer oaths for the purpose of carrying into effect the
- 4 provisions of this section.
- 5 (b) The department is required to maintain a computerized
- 6 fingerprint photo record of all persons making application under
- 7 this section. These records are to be accessed only by
- 8 <u>department personnel for the purpose of determining program</u>
- 9 <u>eligibility.</u>
- 10 Section 2. This act shall take effect in 60 days.
