13	(a) General rule. The standards referenced in Chapters 30	<

- 11 (b) No preemption. -- Nothing contained in this act shall be
- 12 construed to preempt the ability of a municipality to adopt or

- 14 referenced, in whole or in part, in Chapter 35 relating to
- 15 referenced standards or applicable chapter of the 1999 BOCA
- 16 National Building Code, Fourteenth Edition.
- 17 Section 2. The following shall apply:
- 18 (1) The provisions of 34 Pa.Code § 405.2(a)(4) (relating
- 19 to standards) are abrogated absolutely INSOFAR AS THEY RELATE
- 20 TO SKI LIFTS.
- 21 (2) The provisions of 34 Pa.Code § 405.11(e) (relating
- 22 to accident report) are abrogated insofar as they relate to
- 23 ski lifts.
- 24 (3) All other regulations are abrogated to the extent of
- any inconsistency with this act.
- 26 Section 3. This act shall take effect immediately.
