13	(2) Knowingly permit a minor under the age of 18 to
14	patronize, visit or loiter in a place of business in which a
15	video game containing graphic violence is exhibited.
16	(b) Penalty
17	(1) A person that violates subsection (a) commits a
18	misdemeanor of the second degree and shall, upon conviction,

1	be sentenced to pay a fine of \$5,000 or to imprisonment for
2	not more than two years, or both.
3	(2) A person that, after being sentenced under paragraph
4	(1), violates subsection (a) commits a misdemeanor of the
5	first degree and shall, upon conviction, be sentenced to pay
б	<u>a fine of \$10,000 or to imprisonment for not more than five</u>
