| 20 | Section 1801-G. Definitions. |
| 21 | The following words and phrases when used in this article |
| 22 | shall have the meanings given to them in this section unless the |

- 1 context clearly indicates otherwise:
- 2 <u>"Department." The Department of Revenue of the Commonwealth.</u>
- "Energy Star-rated glass or window technologies tax credit"
- 4 or "tax credit." The credit provided under this article.
- 5 "Energy Star-rated glass or window technology." A glass or
- 6 window that has been certified as in compliance with and
- 7 <u>qualifies as an Energy Star product pursuant to the</u>
- 8 Environmental Protection Agency and the Department of Energy,
- 9 Energy Star Program and bears the Energy Star label.
- 10 "Qualified tax liability." The liability for taxes imposed
- 11 under Article III, IV or VI. The term does not include any tax
- 12 withheld by an employer from an employee under Article III.
- 13 <u>"Taxpayer." An entity subject to tax under Article III, IV</u>
- 14 or VI.
- 15 <u>Section 1802-G. Eligible applicants.</u>
- 16 <u>A taxpayer that manufactures Energy Star-rated glass or</u>
- 17 window technologies may apply for the Energy Star-rated glass or
- 18 <u>window technologies tax credit as provided under this article.</u>
- 19 By February 1 of each year, a taxpayer must submit an
- 20 application to the department for the amount of investment in
- 21 the manufacturing of Energy Star-rated glass or window
- 22 technologies that was made in the taxable year that ended the
- 23 <u>prior calendar year.</u>
- 24 <u>Section 1803-G. Award of tax credits.</u>
- 25 A taxpayer that is qualified under section 1802-G may receive
- 26 an Energy Star-rated glass or window technologies tax credit for
- 27 the taxable year in an amount equal to 20% of the total amount
- 28 of all capital, operation and maintenance costs paid for Energy
- 29 Star-rated glass or window technologies in the taxable year to
- 30 be applied against the taxpayer's qualified tax liability.

- 1 <u>Section 1804-G. Carryover and carryback of tax credit.</u>
- 2 (a) Carryover. -- If the taxpayer cannot use the entire amount
- 3 of the Energy Star-rated glass or window technologies tax credit
- 4 for the taxable year in which the tax credit is first approved,
- 5 the excess may be carried over to succeeding taxable years and
- 6 used as a credit against the qualified tax liability of the
- 7 taxpayer for those taxable years. Each time that the tax credit
- 8 <u>is carried over to a succeeding taxable year, it is to be</u>
- 9 reduced by the amount that was used as a credit during the
- 10 immediately preceding taxable year. The tax credit may be
- 11 carried over and applied to succeeding taxable years for no more
- 12 than five taxable years following the first taxable year for
- 13 which the taxpayer was entitled to claim the tax credit.
- 14 (b) Application. -- An Energy Star-rated glass or window
- 15 <u>technologies tax credit approved by the department in a taxable</u>
- 16 year first shall be applied against the taxpayer's qualified tax
- 17 liability for the current taxable year as of the date on which
- 18 the tax credit was approved before the tax credit is applied
- 19 against any tax liability under subsection (a).
- 20 (c) Carryback. -- A taxpayer is not entitled to carry back or
- 21 <u>obtain a refund of an unused Energy Star-rated glass or window</u>
- 22 <u>technologies tax credit</u>.
- 23 Section 1805-G. Availability of tax credits.
- Each fiscal year, \$10,000,000 in tax credits shall be made
- 25 available to the department and may be awarded by the department
- 26 <u>in accordance with this article.</u>
- 27 <u>Section 1806-G. Regulations.</u>
- The department shall promulgate regulations necessary for the
- 29 <u>implementation and administration of this article.</u>
- 30 <u>Section 1807-G. Applicability.</u>

- 1 The tax credit shall apply to tax years beginning after
- 2 <u>December 31, 2014.</u>
- 3 Section 2. This act shall take effect immediately.
