BUZZANCO INTERCHANGE.	<
LO	The General Assembly of the Commonwealth of Pennsylvania	
L1	hereby enacts as follows:	
L2	Section 1. (a) The interchange on Interstate 79 under	
L3	construction in proximity to Western Center in Cecil Township,	
L4	Washington County, is designated and shall be known as	
L5	Southpointe Interchange.	
L6	(b) The portion of State Route 1032 from the interchange	
L7	designated Southpointe Interchange to the entrance of	
L8	Southpointe Interchange from Southpointe is designated and shall	
L9	be known as Southpointe Boulevard.

- 10 SECTION 3. (A) THE SECTION OF ROUTE 19 (PEACH STREET)
- 11 BETWEEN THE SOUTH BOUNDARY LINE OF WATERFORD BOROUGH AND THE
- INTERSECTION OF ROUTE 19 AND ROUTE 20 (26TH AT PEACH STREET) IN 12
- ERIE COUNTY IS DESIGNATED AND SHALL BE KNOWN AS THE GENERAL 13
- 14 STRONG VINCENT MEMORIAL HIGHWAY.
- 15 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND

- SECTION 4. (A) THE INTERCHANGE OF I-79 AND I-90 IN ERIE 19
- 20 COUNTY IS HEREBY DESIGNATED AS THE CHARLES D. BUZZANCO
- 21 INTERCHANGE IN HONOR OF THE LATE CHARLES D. BUZZANCO, FORMER
- 22 BUSINESS MANAGER OF LOCAL UNION 603 OF THE LABORERS'
- 23 INTERNATIONAL UNION OF NORTH AMERICA AND A LEADER OF THE ERIE
- 24 COMMUNITY.
- 25 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 26 MAINTAIN SIGNS TO DISPLAY THE NAME OF THE INTERCHANGE DESCRIBED
- 27 IN SUBSECTION (A).
- 28 Section  $\frac{3}{2}$  5. This act shall take effect in 60 days.
