AN ACT

1 Designating an interchange under construction on Interstate 79
2 in Cecil Township, Washington County, as Southpointe
3 Interchange; ~~and~~ designating a portion of State Route 1032 in <—
4 Cecil Township, Washington County, as Southpointe Boulevard; <—
5 DESIGNATING EXIT 43 OF INTERSTATE ROUTE 80 AS THE RICHARD
6 PETTY EXIT; DESIGNATING A SECTION OF ROUTE 19, ERIE COUNTY,
7 AS THE GENERAL STRONG VINCENT MEMORIAL HIGHWAY; AND
8 DESIGNATING THE INTERCHANGE OF I-79 AND I-90 IN ERIE COUNTY
9 AS THE CHARLES D. BUZZANCO INTERCHANGE.

10 The General Assembly of the Commonwealth of Pennsylvania
11 hereby enacts as follows:

12 Section 1. (a) The interchange on Interstate 79 under
13 construction in proximity to Western Center in Cecil Township,
14 Washington County, is designated and shall be known as
15 Southpointe Interchange.

16 (b) The portion of State Route 1032 from the interchange
17 designated Southpointe Interchange to the entrance of
18 Southpointe Interchange from Southpointe is designated and shall
19 be known as Southpointe Boulevard.

20 ~~Section 2.~~ (C) The Department of Transportation shall erect <—

1 and maintain appropriate signs identifying the interchange
2 described in ~~section 1(a)~~ SUBSECTION (A) as the Southpointe <—
3 Interchange and the portion of State Route 1032 described in
4 ~~section 1(b)~~ SUBSECTION (B) as Southpointe Boulevard. <—
5 SECTION 2. (A) EXIT 43 OF INTERSTATE ROUTE 80 IS DESIGNATED <—
6 AS THE RICHARD PETTY EXIT.
7 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
8 MAINTAIN APPROPRIATE SIGNS IDENTIFYING THE EXIT IN SUBSECTION
9 (A) AS THE RICHARD PETTY EXIT.
10 SECTION 3. (A) THE SECTION OF ROUTE 19 (PEACH STREET)
11 BETWEEN THE SOUTH BOUNDARY LINE OF WATERFORD BOROUGH AND THE
12 INTERSECTION OF ROUTE 19 AND ROUTE 20 (26TH AT PEACH STREET) IN
13 ERIE COUNTY IS DESIGNATED AND SHALL BE KNOWN AS THE GENERAL
14 STRONG VINCENT MEMORIAL HIGHWAY.
15 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
16 MAINTAIN APPROPRIATE SIGNS IDENTIFYING THE PORTION OF ROUTE 19
17 DESCRIBED IN SUBSECTION (A) AS THE GENERAL STRONG VINCENT
18 MEMORIAL HIGHWAY.
19 SECTION 4. (A) THE INTERCHANGE OF I-79 AND I-90 IN ERIE
20 COUNTY IS HEREBY DESIGNATED AS THE CHARLES D. BUZZANCO
21 INTERCHANGE IN HONOR OF THE LATE CHARLES D. BUZZANCO, FORMER
22 BUSINESS MANAGER OF LOCAL UNION 603 OF THE LABORERS'
23 INTERNATIONAL UNION OF NORTH AMERICA AND A LEADER OF THE ERIE
24 COMMUNITY.
25 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
26 MAINTAIN SIGNS TO DISPLAY THE NAME OF THE INTERCHANGE DESCRIBED
27 IN SUBSECTION (A).
28 Section 3 5. This act shall take effect in 60 days. <—
