A RESOLUTION

- Designating the week of October 20 through 24, 2014, as 1 "Juvenile Detention Centers and Alternative Programs Week" in 2 Pennsylvania. 3 4 WHEREAS, Pennsylvania has begun to reserve the use of secure detention for only high-risk youth offenders and is using 5 6 alternative programming for moderate and low-risk offenders in order to improve outcomes for youth and ensure the protection of 7 the community; and 8 9 WHEREAS, Pennsylvania's 15 secure detention centers and the 10 numerous alternative programs serving all 67 counties should be 11 recognized for their ongoing protection of our communities and 12 the service to youth in their custody or care; and 13 WHEREAS, Secure detention facilities provide 726 beds 14 Statewide for approximately 15,000 admissions to juvenile 15 detention in this Commonwealth; and
- 16 WHEREAS, The existence of these facilities and programs
- 17 provides a key service to ensure community and individual
- 18 protection; and

- 1 WHEREAS, Pennsylvania's juvenile detention centers and
- 2 alternative programs, adhering to the balanced and restorative
- 3 justice model, contribute to public safety by providing a stable
- 4 environment for at-risk youth, both preadjudicated and
- 5 adjudicated, providing education and programming and ensuring
- 6 sufficient opportunities for growth and development of
- 7 Pennsylvania's youth; and
- 8 WHEREAS, Through the continuing efforts of the juvenile
- 9 courts of this Commonwealth, juvenile detention is utilized only
- 10 when lesser restrictive environments are not in the best
- 11 interest of the youth or community; and
- 12 WHEREAS, Juvenile detention centers and alternative programs
- 13 ensure every child's health and well-being by providing
- 14 competency development, self-discipline and stabilization
- 15 through comprehensive evaluations, both physical and behavioral
- 16 health, as well as community involvement; and
- 17 WHEREAS, Hundreds of men and women are dedicated to ensuring
- 18 the proper care and supervision of youth and are committed to
- 19 the protection of communities in this Commonwealth on a daily
- 20 basis; and
- 21 WHEREAS, Youth care workers in this Commonwealth's detention
- 22 facilities and alternative programs stand ready on a daily basis
- 23 to respond to youth who display an array of unresolved mental
- 24 health, behavioral, educational and emotional issues; and
- 25 WHEREAS, The Juvenile Detention Centers and Alternative
- 26 Programs is an association that acts as a primary resource for
- 27 these facilities offering education, representation and support
- 28 for all of the important services that juvenile detention
- 29 centers and alternative programs provide for this Commonwealth's
- 30 youth and communities; and

- 1 WHEREAS, Juvenile detention centers and alternative programs
- 2 in this Commonwealth, in coordination with the Juvenile
- 3 Detention Centers and Alternative Programs, merit one week of
- 4 recognition for their unending services aimed at protecting our
- 5 communities and assisting Pennsylvania's youth; therefore be it
- 6 RESOLVED, That the Senate designate the week of October 20
- 7 through 24, 2014, as "Juvenile Detention Centers and Alternative
- 8 Programs Week" in Pennsylvania.
