AN ACT Amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in municipal pensions, providing for 2 pension service credit for prior service with police 3 4 department. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Chapter 91 of Title 53 of the Pennsylvania Consolidated Statutes is amended by adding a subchapter to read: 8 9 SUBCHAPTER C 10 POLICE PENSION PLANS 11 Sec. 12 9121. Definitions. 9122. Pension service credit for prior service with police 13 14 department. 15 9123. Computation of amount due. 16 9124. Ineligibility.

The following words and phrases when used in this subchapter

shall have the meanings given to them in this section unless the

- 1 context clearly indicates otherwise:
- 2 "Police department." This term shall have the same meaning
- 3 as provided under section 2162 (relating to definitions).
- 4 "Police officer." This term shall have the same meaning as
- 5 provided under section 2162.
- 6 § 9122. Pension service credit for prior service with police
- 7 <u>department</u>.
- 8 A city, other than a city of the first class, borough, town,
- 9 township or regional police department shall amend its ordinance
- 10 or resolution establishing a police pension fund to provide
- 11 <u>full-time police officers the option to purchase up to five</u>
- 12 years of pension service credit for prior part-time or full-time
- 13 police service provided in a police department.
- 14 § 9123. Computation of amount due.
- The amount due for the purchase of credit for prior police
- 16 <u>service shall be computed by:</u>
- 17 (1) multiplying the normal cost rate for the police
- 18 pension plan a police officer is buying into, but not to
- 19 <u>exceed 10%, by the police officer's average annual rate of</u>
- 20 compensation over the first three years of service with the
- 21 police department; and
- 22 (2) multiplying the product from paragraph (1) by the
- 23 number of years and fractional part of a year of creditable
- 24 prior police service being purchased together with interest
- at the rate of 4.75% compounded annually from the date of
- 26 initial entry into full-time service with the police
- 27 <u>department to the date of payment.</u>
- 28 § 9124. Ineligibility.
- 29 The following apply:
- 30 (1) No police officer shall be eligible to purchase

- 1 <u>service credit for prior police service for which the officer</u>
- 2 otherwise receives or is entitled to receive pension service
- 3 <u>credit from any other pension fund.</u>
- 4 (2) No police officer shall be eligible to purchase
- 5 <u>service credit for prior police service that combined with</u>
- 6 <u>credited military service exceeds five years.</u>
- 7 Section 2. This act shall take effect in 60 days.
