AN ACT

- 1 Relating to the surrender of oil and gas leases; and providing for certain forms and damages.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Oil and Gas
- 7 Lease Surrender Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- "Lessee." A person who has obtained the right to explore,
- 13 drill, stimulate, produce, market and sell the oil, gas and
- 14 natural gas liquids, or portion of the oil, gas and natural gas
- 15 liquids, by means of a properly executed lease.
- 16 "Lessor." An owner of the oil and gas in place who controls
- 17 the oil and gas rights and has executed a lease.

- 1 Section 3. Surrendering, methods and indexing.
- 2 (a) Methods of surrendering oil and gas leases. --
- 3 (1) Oil and gas leases shall be surrendered by surrender
- 4 documents as described in sections 5 and 6 by the recording
- 5 officer of the applicable county. A surrender document shall
- 6 be accompanied by information sufficient to validate the
- 7 original oil and gas lease recording information in the
- 8 public record, which shall include the following:
- 9 (i) A copy of the recorded memorandum or OF lease
- or, if not available, the original oil and gas lease.
- 11 (ii) A fee established by the recording officer.
- 12 (2) A recording officer shall give notice of the
- recording validation procedure. The notice shall be entitled
- "Notice by (recording officer) to Adopt Recording Information
- 15 Validation Procedure under the Oil and Gas Lease Surrender
- Act," and shall state any additional fees to be charged and
- 17 shall be advertised in the county recorder's yearly fee
- schedule or fee bill, whichever is applicable.
- 19 (b) Indexing. -- The recording officer shall properly index
- 20 all surrender documents against the name of the lessee or last
- 21 assignee as each is indicated in the surrender document and
- 22 shall indicate the recording of each surrender document in the
- 23 oil and gas lease record.
- 24 (c) Liability of recording officer. -- Nothing in this act
- 25 shall impose liability on any recording officer or any political
- 26 subdivision for a mistake, error or inaccuracy found in a
- 27 surrender document which was presented for recording by a person
- 28 or entity and which was recorded by the recording officer or
- 29 political subdivision.
- 30 Section 4. Requirement and effect of surrender document.

- 1 Every lessee shall, within 30 days after expiration,
- 2 termination or forfeiture of the oil and gas lease, present for
- 3 recording in the office where the oil and gas lease is recorded
- 4 a duly executed surrender document in substantially the form set
- 5 out in section 5 and acknowledged as provided by law. The
- 6 surrender document shall thereafter discharge, defeat and
- 7 release a lessee's interests in the lease upon recording.
- 8 Section 5. Form of surrender document.
- 9 A lessee, whether an individual or legal entity, shall
- 10 surrender oil and gas leases by a surrender document in
- 11 substantially the following form:
- 12 SURRENDER DOCUMENT

- 24 The undersigned certifies that the terms secured by the
- above-mentioned oil and gas lease have expired or were
- terminated or forfeited, or otherwise discharged and that
- upon the recording of the oil and gas lease shall be and
- are fully and forever surrendered and discharged. The
- 29 undersigned authorizes and empowers the recording officer
- of the county to enter this surrender document and to

- 1 cause the oil and gas lease to be surrendered of record.
- 2 Witness the due execution of this document with the
- 3 intent to be legally bound. (signature(s) of individual
- 4 lessee(s) or representative(s) of legal entity)
- 5 (acknowledgment)
- 6 Section 6. Notice to surrender and damages for failure to
- 7 surrender.
- 8 (a) Notice.--After the time set forth in section 4, the
- 9 lessor may send a notice to the lessee to present for recording
- 10 a surrender document to avoid damages.
- 11 (b) Delivery. -- The notice to surrender shall be sent to the
- 12 lessee by certified or registered mail, return receipt
- 13 requested. The notice shall be sent to the lessee at the
- 14 lessee's address designated in the oil and gas lease unless the
- 15 person issuing the notice has actually received from the lessee
- 16 another name or address to which a notice is to be sent.
- 17 (c) Form. -- The notice to surrender shall be in substantially
- 18 the following form:
- 19 NOTICE TO RECORD OIL AND GAS
- 20 LEASE SURRENDER DOCUMENT
- TO AVOID PENALTY
- 22 Date of notice:
- To the lessee named below:
- 24 The party issuing this notice believes that the terms of
- 25 the oil and gas lease described below have expired,
- terminated, forfeited or otherwise discharged. The party
- issuing this notice requests that the lessee issue and
- 28 present for recording a surrender document concerning the
- oil and gas lease or provide a satisfactory reason why
- 30 the oil and gas lease should not be surrendered to the

- 1 party issuing this notice. If you do not comply with this
- 2 notice, you may be liable for penalties and costs in
- accordance with this act or the party issuing this notice
- 4 may be able to surrender the oil and gas lease without
- 5 your consent.

- 18 (d) Penalty for failure to surrender.--
- 19 (1) If, within 60 days of the lessee's receipt of the
- first written request by the lessor for the surrender
- 21 document, delivered and in substantially the form described
- in this section, the lessee fails to present for recording to
- 23 the office where the oil and gas lease was recorded a
- surrender document as described in section 5 or the oil and
- gas lease is not otherwise surrendered, the lessor may
- 26 initiate an appropriate court action to compel surrender of
- 27 the lease, unless a satisfactory reason was provided by the
- lessee as to why the oil and gas lease should not be
- 29 surrendered.
- 30 (2) In a successful action to compel surrender of the

- lease, the lessee shall reimburse the lessor for costs of the
- 2 action, including the lessor's reasonable attorney fees.
- 3 (3) An action under this section shall be the exclusive
- 4 remedy for damages for failure of a lessee to issue and
- 5 present for recording a surrender document.
- 6 (4) The delivery of a second or subsequent written
- 7 request by the lessor for a surrender document shall not give
- 8 rise to an additional cause of action under this section.
- 9 Section 7. Other rules or laws not affected.
- 10 This act shall not affect nor impair any other act or any
- 11 rule of civil procedure promulgated by the Pennsylvania Supreme
- 12 Court, which provides for the surrender or discharge of an oil
- 13 and gas lease by order or decree of any court upon payment of an
- 14 applicable fee. The recording officer shall accept for recording
- 15 a copy of the order or decree certified by the prothonotary and
- 16 shall index and indicate the same in the record as is provided
- 17 in this act for a surrender document. Except as provided in
- 18 section 3(a), this act shall not affect or impair any other act
- 19 providing for fees for the recording of the documents and
- 20 instruments provided for in this act.
- 21 Section 8. Prior instruments.
- 22 Written surrender or intended surrender given prior to the
- 23 effective date of this section with respect to any oil and gas
- 24 lease on real property situate in this Commonwealth shall be
- 25 deemed good, valid and effective in law for the purposes therein
- 26 recited.
- 27 Section 9. Applicability.
- Unless otherwise specified by contract, this act shall apply
- 29 to every oil and gas lease on real property in this Commonwealth
- 30 which has not been surrendered prior to the effective date of

- 1 this section and regardless of whether the oil and gas lease was
- 2 executed before the effective date of this section.
- 3 Section 10. Effective date.
- 4 This act shall take effect in 60 days.
