## AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
  - Pennsylvania Consolidated Statutes, in facilities and
- supplies, further providing for surcharge; and, in access to
- 4 justice, repealing provisions relating to expiration of
- 5 chapter.

- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 3733.1 of Title 42 of the Pennsylvania
- 9 Consolidated Statutes, amended July 7, 2011 (P.L.207, No.30), is
- 10 amended to read:
- 11 § 3733.1. Surcharge.
- 12 (a) Imposition of surcharge. -- In addition to each fee
- 13 imposed under section 3733(a.1) (relating to deposits into
- 14 account), [except as set forth in subsection (b),] the following
- 15 apply:
- 16 (1) A surcharge of [\$11.25]  $\frac{\$10.25}{10.25}$  shall be charged and
- 17 collected. This paragraph shall expire December 31, 2014.
- 18 (2) A permanent fee of \$2.25 shall be charged and
- 19 collected.

- 1 (3) A permanent fee of \$1 shall be charged and
- 2 collected.
- 3 [(b) Exceptions. -- Subsection (a) does not apply to a
- 4 conviction or guilty plea based on the filing of a traffic
- 5 citation charging an offense under 75 Pa.C.S. (relating to
- 6 vehicles) which is classified as summary under a State statute
- 7 or local ordinance as provided in the Pennsylvania Rules of
- 8 Criminal Procedure.]
- 9 (c) Allocation and appropriation. --
- 10 (1) The surcharge under subsection (a) (1) [shall be
- 11 allocated as follows:
- 12 (i) One dollar shall be deposited into the Access to
- 13 Justice Account.
- 14 (ii) The remainder of money] shall be deposited into
- a separate reserve account within the Judicial Computer
- System Augmentation Account. Notwithstanding section 3732
- 17 (relating to utilization of funds in account), money
- deposited under this [subparagraph] paragraph is hereby
- appropriated to the Supreme Court, upon compliance with
- 20 Article XV of the act of April 9, 1929 (P.L.343, No.176),
- 21 known as The Fiscal Code, for the operation of the
- Judicial Department.
- 23 (2) The fee under subsection (a)(2) shall be deposited
- into the Criminal Justice Enhancement Account.
- 25 (3) The fee under subsection (a) (3) shall be deposited
- into the Access to Justice Account.
- 27 Section 2. Section 4907 of Title 42 is repealed:
- 28 [§ 4907. Expiration of chapter.
- 29 This chapter shall expire on November 1, 2012. At least one
- 30 year prior to the expiration of this chapter, the Legislative

- 1 Budget and Finance Committee shall conduct and submit to the
- 2 General Assembly a performance audit for the purpose of
- 3 determining whether there is a continuing justification for the
- 4 activities and level of financial support provided for under
- 5 this chapter.]
- 6 Section 3. This act shall take effect as follows:
- 7 (1) The amendment of 42 Pa.C.S. § 3733.1 shall take
- 8 effect in 30 days.
- 9 (2) The remainder of this act shall take effect
- immediately.
