AN ACT

- 1 Making appropriations to The Medical College of Pennsylvania,
- 2 East Falls, Philadelphia, Pennsylvania.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The sum of \$2,046,000, or as much thereof as may
- 6 be necessary, is hereby specifically appropriated to The Medical
- 7 College of Pennsylvania located in East Falls, Philadelphia,
- 8 Pennsylvania, for its fiscal period July 1, 1980 to June 30,
- 9 1981 for instruction in the Doctor of Medicine program.
- 10 Section 2. The sum of \$260,000, or as much thereof as may be
- 11 necessary, is hereby appropriated to The Medical College of
- 12 Pennsylvania, Philadelphia, Pennsylvania, for the fiscal period
- 13 July 1, 1980 to June 30, 1981, for the general maintenance of
- 14 The Medical College of Pennsylvania including the School of
- 15 Allied Health and student aid.
- 16 Section 3. Payments to The Medical College of Pennsylvania,
- 17 on account of the appropriation for instruction in the Doctor of

- 1 Medicine program as provided in section 1 shall be made by the
- 2 Secretary of Education on the basis of full-time student
- 3 enrollment at the rate of \$4,400 per student.
- 4 Section 4. Payments to The Medical College of Pennsylvania
- 5 on account of the appropriation for the School of Allied Health
- 6 as provided in section 2 shall be made by the Secretary of
- 7 Education on the basis of costs during the fiscal year.
- 8 Section 5. The college shall provide such information as may
- 9 be necessary to carry out the provisions of this act and in such
- 10 form and manner as the Department of Education may prescribe.
- 11 Section 6. The Medical College of Pennsylvania shall report
- 12 its revenues and expenditures and present its financial
- 13 statements in accordance with generally accepted accounting
- 14 principles and procedures for educational institutions as set
- 15 forth in the "Higher Education Finance Manual of 1975" without
- 16 exception.
- 17 Section 7. All sums of money paid to The Medical College of
- 18 Pennsylvania pursuant to the appropriation of the act of July
- 19 11, 1980 (No.39A), entitled "An act making appropriations to The
- 20 Medical College of Pennsylvania, East Falls, Philadelphia,
- 21 Pennsylvania, " shall be credited toward and deducted from the
- 22 amount appropriated in this act.
- 23 Section 8. The act of July 11, 1980 (No.39A), entitled "An
- 24 act making appropriations to The Medical College of
- 25 Pennsylvania, East Falls, Philadelphia, Pennsylvania, "is
- 26 repealed.
- 27 Section 9. This act shall take effect immediately.
