7	Section 1. Article VII, act of June 13, 1967 (P.L.31,	
8	No.21), known as the "Public Welfare Code," is amended by adding	
9	a subarticle heading and sections to read:

13	(e) Adoption Subsidies OPPORTUNITIES ACT	<
14	Section 771. Declaration of Purpose This subarticle shall	
15	be interpreted and construed so as to effect the following	
16	purpose: to encourage and promote the placement in adoptive	
17	homes of children whose sociocultural background, MENTAL,	<
18	emotional or physical handicap, age, or size of sibling group	<

- 1 imposes an obstacle to placement. unless adoptive parents, who
- 2 <u>are otherwise suitable to provide a good adoptive home, receive</u>
- 3 <u>an adoption subsidy to fulfill their financial responsibility</u>
- 4 towards the adopted child.
- 5 <u>Section 772. Definitions.--As used in this subarticle:</u>
- 6 <u>"Adoption subsidy" OPPORTUNITY" may include maintenance cost, <--</u>
- 7 medical and surgical expenses and other costs incident to the
- 8 adoption placement.
- 9 <u>"Child" means an individual who is under the age of eighteen</u>
- 10 years.
- 11 <u>"Eligible child" means a child in the legal custody of local</u>
- 12 authorities where parental rights have been terminated pursuant
- 13 to the procedure set forth in Article III of the act of July 24,
- 14 1970 (P.L.620, No.208), known as the "Adoption Act," and such
- 15 <u>child has been in foster placement for a period of not less than</u>
- 16 six months and where the child may HAS BEEN SHOWN TO be a
- 17 difficult adoption placement because of the child's racial or <-
- 18 cultural heritage, age, or physical, emotional or mental
- 19 handicap, or because the child is a member of a sibling group,
- 20 which should be kept intact.
- 21 <u>"Local authorities" means county institution districts or</u>
- 22 their successors.
- 23 Section 773. Rules and Regulations. -- (a) The Department of
- 24 Public Welfare shall establish and develop criteria and
- 25 <u>promulgate necessary regulations for public child welfare</u>
- 26 agencies to implement an adoption subsidy OPPORTUNITY in
- 27 accordance with the provisions of this subarticle (e).
- 28 (b) The regulations shall include, but not be limited to,
- 29 <u>criteria for identifying eligible children and adoptive homes</u>,
- 30 procedures for implementing the subsidy, and reporting

- 1 requirements by public child welfare agencies.
- 2 (c) All regulations established pursuant to this section
- 3 shall be adopted pursuant to the act of July 31, 1968 (P.L.769,
- 4 No.240), known as the "Commonwealth Documents Law," and the
- 5 hearings referred to in section 202 of that act shall be
- 6 mandatory.
- 7 Section 774. Adoption Subsidy OPPORTUNITY Payments and
- 8 Reimbursement. -- (a) The amount of adoption subsidy for
- 9 <u>maintenance costs to an adoptive family shall not exceed the</u>
- 10 <u>amount available as foster family care in the county in which</u>
- 11 <u>the child is adopted.</u>
- 12 (b) (A) The department shall reimburse local authorities for <---

- 13 at least seventy five percent (75%) ONE HUNDRED PERCENT (100%)
- 14 of the cost of an adoption subsidy provided by local authority
- 15 pursuant to the provisions of this subarticle (e), provided the
- 16 <u>local authority complies with the reporting requirements</u>
- 17 <u>established by the department pursuant to section 773.</u>
- 18 (c) (B) No public funds shall be expended under this
- 19 subarticle (e) on behalf of an eligible child until all
- 20 <u>available benefits under existing or future private, public,</u>
- 21 local, State, or Federal programs have been exhausted.
- 22 Notwithstanding any other provision of law, adoptive parents
- 23 CHILDREN subsidized under the provisions of this subarticle (e)
- 24 shall not be liable pursuant to the provisions of the act of
- 25 October 20, 1966 (Sp. Sess. No.3, P.L.96, No.6), known as the
- 26 "Mental Health and Mental Retardation Act of 1966," or the act
- 27 of June 24, 1937 (P.L.2045, No.397), known as "The Support Law,"
- 28 in the event that the adopted child needs services or assistance
- 29 <u>under the provisions of Article IV of this act or under the</u>
- 30 provisions of the "Mental Health and Mental Retardation Act of

- 1 1966."
- 2 Section 2. This act shall take effect immediately so as to
- 3 permit the Department of Public Welfare to establish
- 4 regulations, but no adoption subsidy PAYMENTS shall be paid MADE <--
- 5 prior to July 1, 1975.
