5 MAKING AN APPROPRIATION OUT OF THE MOTOR LICENSE FUND TO THE <—
6 DEPARTMENT OF HIGHWAYS FOR THE APPALACHIAN LOCAL ACCESS ROADS
7 PROGRAM.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 ~~Section 1. Section 3, act of June 30, 1966 (No. 29 A),~~ <—
11 ~~entitled "An act making an appropriation out of the Motor~~
12 ~~License Fund to the Department of Highways for the Appalachian~~
13 ~~Local Access Roads program," amended June 30, 1971 (No. 12 A), is~~

15 ~~Section 3. Whatsoever of the amounts herein appropriated are~~
16 ~~unexpended or unencumbered as of June 30, [1973] 1975 shall~~
17 ~~lapse.~~

18 SECTION 1. THE SUM OF ONE MILLION ONE HUNDRED SEVENTY-TWO <—
19 THOUSAND FIVE HUNDRED DOLLARS (\$1,172,500), OR AS MUCH THEREOF
20 AS MAY BE NECESSARY, IS HEREBY SPECIFICALLY APPROPRIATED OUT OF

1 THE MOTOR LICENSE FUND TO THE DEPARTMENT OF HIGHWAYS FOR THE
2 APPALACHIAN LOCAL ACCESS ROADS PROGRAM IN ACCORDANCE WITH THE
3 APPALACHIAN REGIONAL DEVELOPMENT ACT OF 1965, PUBLIC LAW 89-4,
4 89TH CONGRESS, S. 3, MARCH 9, 1965, TO CARRY OUT ALL OF THE
5 POWERS AND DUTIES THEREOF, FOR THE CONSTRUCTION OF ACCESS ROADS
6 TO PUBLIC PARKS, RESORT AREAS AND INDUSTRIAL CENTERS.

7 SECTION 2. REIMBURSEMENT FROM THE FEDERAL GOVERNMENT UNDER
8 THE PROVISIONS OF THE APPALACHIAN REGIONAL DEVELOPMENT ACT OF
9 1965 FOR THE CONSTRUCTION OF LOCAL ACCESS ROADS SHALL BE
10 SPECIFICALLY CREDITED TO THIS APPROPRIATION.

11 SECTION 3. WHATSOEVER OF THE AMOUNTS HEREIN APPROPRIATED ARE
12 UNEXPENDED OR UNENCUMBERED AS OF JUNE 30, 1975 SHALL LAPSE.

13 SECTION 4. THIS ACT SHALL TAKE EFFECT IMMEDIATELY.
