## AN ACT

Amending the act of June 1, 1956 (P.L.1959, No.657), entitled, as amended, "An act fixing the salaries and compensation of 3 the Chief Justice and judges of the Supreme Court, the President Judge and judges of the Superior Court, the judges of the courts of common pleas, the judges of the orphans' courts, the judges of the County Court of Philadelphia and 7 the judges of the County Court and Juvenile Court of Allegheny County, certain associate judges not learned in the 9 law, certain state officers, and the salary and expenses of the members of the General Assembly, and repealing certain 10 inconsistent acts," making a change relating to time of 11 12 payment AND CONFORMING LANGUAGE TO THE REPORTS OF THE 13 COMMONWEALTH COMPENSATION COMMISSION.

14 The General Assembly of the Commonwealth of Pennsylvania

15 hereby enacts as follows:

- 16 Section 1. Section 14, act of June 1, 1956 (P.L.1959,
- 17 No.657), entitled, as amended, "An act fixing the salaries and
- 18 compensation of the Chief Justice and judges of the Supreme
- 19 Court, the President Judge and judges of the Superior Court, the
- 20 judges of the courts of common pleas, the judges of the orphans'
- 21 courts, the judges of the County Court of Philadelphia and the

- 1 judges of the County Court and Juvenile Court of Allegheny
- 2 County, certain associate judges not learned in the law, certain
- 3 state officers, and the salary and expenses of the members of
- 4 the General Assembly, and repealing certain inconsistent acts,"
- 5 amended June 16, 1971 (P.L.157, No.8), is amended to read:
- 6 Section 14. The salary of the members of the General
- 7 Assembly shall be [seven thousand two hundred dollars (\$7,200)] <---
- 8 FIFTEEN THOUSAND SIX HUNDRED DOLLARS (\$15,600) per annum and
- 9 mileage to and from their homes at the rate of [ten cents (10¢)] <---
- 10 TWELVE CENTS (12¢) per mile circular, for each week a member was <---
- 11 in actual attendance at the session, between their homes and the
- 12 State capitol, and no other compensation shall be allowed
- 13 whatsoever, except each member of the General Assembly shall
- 14 receive an allowance for clerical assistance and other expenses
- 15 incurred during his term in connection with the duties of his
- 16 office, in the sum of [eight thousand four hundred dollars
- 17 (\$8,400), FIVE THOUSAND DOLLARS (\$5,000), annually; the salary
- 18 and expenses to be payable in equal monthly installments on the
- 19 first of the month [with the exception that the installment due
- 20 December first of each even year shall be added to and payable
- 21 with the installment due January first of the following year].
