AN ACT

- 1 Amending the act of April 29, 1959 (P.L.58, No.32), entitled "An act consolidating and revising the Vehicle Code, the Tractor
- 3 Code, the Motor Vehicle Financial Responsibility Act and
- 4 other acts relating to the ownership, possession and use of
- 5 vehicles and tractors, " changing the income requirement of
- 6 persons entitled to a reduced registration fee.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 702, act of April 29, 1959 (P.L.58,
- 10 No.32), known as "The Vehicle Code," amended May 10, 1974
- 11 (No.83), is amended to read:
- 12 Section 702. Motor Vehicles.--The fee for annual
- 13 registration of motor vehicles, except as provided in this act,
- 14 shall be fourteen dollars (\$14.00), and, if the department shall
- 15 be requested by the applicant for registration to assign to
- 16 motor vehicles any special series of registration plates for
- 17 which no additional fee is expressly provided for by this act,
- 18 an additional fee in an amount equal to the fee for annual
- 19 registration of each such motor vehicle. Such annual
- 20 registration fee shall be ten dollars (\$10.00) for any person

- 1 owning the motor vehicle who is retired and receiving social
- 2 security or other pension and whose total income does not exceed
- 3 [three thousand five hundred dollars (\$3,500.00)] four thousand
- 4 <u>dollars (\$4,000.00)</u> per year. No such motor vehicle shall be a
- 5 commercial or income-producing motor vehicle and no such motor
- 6 vehicle shall be operated by any person other than the owner
- 7 given the reduced registration fee or any person authorized by
- 8 the owner to operate the motor vehicle. Every such person
- 9 claiming such reduced annual registration fee shall submit
- 10 annually with the license application a statement in writing
- 11 affirming the retired, social security or pension status and
- 12 setting forth the total income for the previous year. Every such
- 13 operator granted the reduced registration fee shall carry a
- 14 special owner's card designed and issued by the department. The
- 15 department may require specially designed license plates or
- 16 stickers for motor vehicles of owners granted the reduced
- 17 registration fee.
- 18 Section 2. This act shall take effect in 60 days.
