AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 2 3 special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 11 elections, " limiting a candidate to one financial committee 12 and further providing for payments to or on behalf of a 13 candidate. 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1602, act of June 3, 1937 (P.L.1333, Section 1. 17 No.320), known as the "Pennsylvania Election Code," is amended 18 to read: 19 Section 1602. Political Committees; Treasurer.--(a) Every 20 political committee shall appoint and constantly maintain a 21 treasurer to receive, keep and disburse all sums of money which

may be collected or received by such committee, or by any of its

- 1 members for primary or election expenses; and unless such
- 2 treasurer is first appointed and thereafter maintained, it shall
- 3 be unlawful for a political committee or any of its members to
- 4 collect, receive or disburse money or incur liability for any
- 5 such purpose. All money collected or received by any political
- 6 committee, or by any of its members for primary or election
- 7 expenses, shall be paid over and made to pass through the hands
- 8 of the treasurer of such committee and shall be disbursed by
- 9 him; and it shall be unlawful for any political committee, or
- 10 any of its members, to disburse any money for primary or
- 11 election expenses, unless such money shall have passed through
- 12 the hands of the treasurer.
- (b) Notwithstanding any other provisions of this act, each
- 14 candidate shall have only one financial committee the treasurer
- 15 of which shall be the campaign treasurer.
- 16 (c) Funds for the cost of materials, advertisements and
- 17 other services solely for an individual candidate shall be paid
- 18 to the candidate or his financial committee: Provided, however,
- 19 That funds for joint advertisements and services with another
- 20 candidate shall not be included in the scope of this subsection.
- 21 Section 2. This act shall take effect in 60 days.
