AN ACT

- 1 Establishing the Tricentennial Commission of Pennsylvania,
- 2 providing for the powers and duties of the commission, and
- 3 making an appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the
- 8 "Tricentennial Commission Act."
- 9 Section 2. Legislative findings; declaration of policy.
- 10 It is hereby determined and declared as a matter of
- 11 legislative finding:
- 12 (1) The tricentennial of the founding of the
- 13 Commonwealth of Pennsylvania occurs in 1981.
- 14 (2) No other state has furnished as many leaders or
- played as dominant a role in the development of our national
- 16 heritage, individual liberty and representative government.
- 17 (3) Pennsylvania, birthplace of our liberty, should take
- 18 steps to encourage historical preservation and restoration,

- 1 the recreation of events and remembrances of our historic
- 2 beginning, and the promotion of international and national
- 3 tourism designed to highlight the heritage and contributions
- 4 of Pennsylvania to the Nation.
- 5 Section 3. Establishment of commission; membership; vacancies.
- 6 (a) There is hereby established the Tricentennial Commission
- 7 of Pennsylvania, hereafter referred to as the commission, to
- 8 plan and develop Pennsylvania's participation in the
- 9 commemoration of the founding of this Commonwealth.
- 10 (b) The commission shall be composed of the following:
- 11 (1) Five members of the State Senate to be appointed by
- the President pro tempore of the Senate.
- 13 (2) Five members of the House Representatives to be
- appointed by the Speaker of the House of Representatives.
- 15 (3) The Lieutenant Governor, Secretary of Commerce,
- 16 Secretary of Environmental Resources, the Chairman of the
- 17 Pennsylvania Historical and Museum Commission, and the
- 18 Secretary of the Commonwealth.
- 19 (4) Ten persons to be appointed by the Governor.
- 20 (c) The Governor of Pennsylvania shall be Honorary Chairman
- 21 of the commission and shall designate from among the members
- 22 thereof the chairman of the commission.
- 23 (d) Vacancies in the commission shall be filled in the same
- 24 manner in which the original appointments were made.
- 25 Section 4. Duties of commission.
- 26 The duties of the commission shall include the following:
- 27 (1) To develop an effective observance by this
- 28 Commonwealth of the tricentennial.
- 29 (2) To plan effective tricentennial programs for
- 30 Pennsylvania and for its historic cities and regions,

- 1 coordinating such plans with programs which may be developed
- 2 by local governments or other recognized organizations.
- 3 (3) To undertake a feasibility study to institute a
- 4 program of designating historic preservation and restoration
- 5 districts in the municipalities in which restoration and
- 6 preservation activities are undertaken.
- 7 Section 5. Meetings and hearings.
- 8 The commission shall establish a regular schedule of meetings
- 9 at its first session, which will be on the call of its chairman
- 10 as soon as possible after the members have been appointed. The
- 11 commission will hold public hearings as may be necessary to
- 12 encourage citizens of Pennsylvania to offer their
- 13 recommendations regarding the tricentennial.
- 14 Section 6. Reports.
- 15 The commission shall submit each year a report to the
- 16 Governor and to the General Assembly covering its activities and
- 17 offering its recommendations. A final report on all phases of
- 18 its activities shall be submitted the year following the
- 19 completion of Pennsylvania's Tricentennial observances.
- 20 Section 7. Assistance from the Department of Commerce.
- 21 The Department of Commerce shall provide such secretarial and
- 22 other staff assistance as may be necessary to the proper
- 23 functioning of the commission consistent with the laws of the
- 24 Commonwealth.
- 25 Section 8. Finances and contributions.
- 26 Funds which may be appropriated by the General Assembly from
- 27 time to time to assist in financing the tricentennial shall be
- 28 appropriated to the Department of Commerce. That department
- 29 shall secure the advice of the commission in preparing requests
- 30 for such appropriations and in their expenditure.

- 1 Section 9. Appropriations.
- There is hereby appropriated to the Department of Commerce,
- 3 to assist the work of the commission, the sum of \$25,000 for the
- 4 fiscal year July 1, 1977 to June 30, 1978. In addition to this
- 5 amount, all moneys received from any other sources as
- 6 contributions to this program shall be paid into the General
- 7 Fund and credited to this appropriation.
- 8 Section 10. Effective date.
- 9 This act shall take effect July 1, 1977.
