- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the issuance of registration
- 3 plates bearing the call letters of amateur radio operators
- 4 and establishing a special fee.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 1341 and 1931 of Title 75, act of
- 8 November 25, 1970 (P.L.707, No.230), known as the Pennsylvania
- 9 Consolidated Statutes, added June 17, 1976 (No.81), are amended
- 10 to read:
- 11 § 1341. Personal plate.
- 12 <u>(a) General rule.--</u>Upon request by the applicant, the
- 13 department may issue registration plates consisting of any
- 14 combination of numbers, letters or numbers and letters. These
- 15 special plates may be issued for special groups or for special
- 16 purposes and bear an appropriate designation. They shall have
- 17 the same force and effect as regular registration plates. The
- 18 department may refuse any combination of letters and numbers for
- 19 cause and shall adopt reasonable rules and regulations for the

- 1 issuance of the plates and for carrying out the provisions of
- 2 this section. The applicant shall comply with all laws and
- 3 regulations pertaining to registration including the payment of
- 4 any additional fees.
- 5 (b) Amateur radio operators.--Upon request by an applicant
- 6 who holds a valid Federal Communications Commission amateur
- 7 radio station license, the department shall issue a registration
- 8 plate which shall carry the call letters of the amateur radio
- 9 station. The special registration plate shall have the same
- 10 force and effect as regular registration plates. The applicant
- 11 shall comply with all laws and regulations pertaining to
- 12 registration including the payment of any additional fees.
- 13 § 1931. Personal registration plates.
- 14 (a) General rule. -- The fee for issuance of a personal
- 15 registration plate shall be \$20 which shall be in addition to
- 16 the annual registration fee. Only one payment of the issuance
- 17 fee shall be charged for each personal registration issued or
- 18 replaced.
- 19 (b) Amateur radio operators. -- The fee for issuance of a
- 20 personal registration plate which bears the call letters of an
- 21 amateur radio station shall be \$3 which shall be in addition to
- 22 the annual registration fee. Only one payment of the issuance
- 23 fee shall be charged for each amateur radio station registration
- 24 plate issued or replaced.
- 25 Section 2. This act shall take effect immediately.
