AN ACT

- 1 Providing for standards and labeling of insulation material.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Legislative intent.
- 5 It is the intent of the General Assembly that in order to
- 6 help meet future energy requirements and to protect the
- 7 consumers of the Commonwealth, it is necessary to adopt
- 8 standards for insulation material and to provide for the
- 9 labeling of such materials.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have, unless the context clearly indicates otherwise, the
- 13 meanings given to them in this section:
- 14 "Approved testing laboratory." Any testing facility which is
- 15 determined by rule and regulation of the department to have
- 16 adequate personnel and expertise to carry out the testing of
- 17 insulation material.

- 1 "Department." The Department of Labor and Industry.
- 2 "Insulation material." Any material placed within or
- 3 contiguous to a wall, ceiling or floor of a room or building, or
- 4 contiguous to the surface of any appliance or its intake or
- 5 outtake mechanism, for the purpose of reducing heat transfer and
- 6 thus the energy requirements for heating or cooling the building
- 7 or operating the appliance or reducing adverse temperature
- 8 fluctuations of the building, room or appliance.
- 9 "R-value." A measure of thermal resistance of material or
- 10 composite materials. R-value as used herein is equal to the
- 11 reciprocal of the conductance of a given material, or
- 12 R-value = 1

- 14 conductance of the material
- 15 where the conductance of the material is: Btu/(hour x square
- 16 feet x fahrenheit degree average temperature difference between
- 17 two surfaces).
- 18 Section 3. Adoption of standards; elements; criteria.
- 19 The department shall, after one or more public hearings,
- 20 adopt and publish insulation material standards governing the
- 21 grade, quality and safety of all insulation material sold or
- 22 installed within the Commonwealth, including but not limited to,
- 23 the following characteristics:
- 24 (1) resistance to heat transfer (expressed in term of R-
- value of the material when installed under specified
- 26 conditions);
- 27 (2) fire retardance;
- 28 (3) smoke spread;
- 29 (4) flame spread;
- 30 (5) moisture absorption;

- 1 (6) resistance to fungal growth;
- 2 (7) corrosiveness;
- 3 (8) starch content;
- 4 (9) density;
- 5 (10) odor emission; and
- 6 (11) flame resistance permanency.
- 7 The standards adopted shall insure that insulation material will
- 8 effect significant energy savings and shall protect the health
- 9 and welfare of the citizens of the Commonwealth. Such standards
- 10 shall specify the initial performance of the material and the
- 11 stability of performance over a period of time.
- 12 Section 4. Application of standards.
- 13 Six months after such standards are adopted as regulations in
- 14 accordance with the act of July 31, 1968 (P.L.769, No.240),
- 15 known as the "Commonwealth Documents Law," no insulation
- 16 material shall be sold or installed in the Commonwealth which
- 17 has not been tested by an independent approved testing
- 18 laboratory and certified by the department, or its authorized
- 19 agents, as meeting such standards. The department shall
- 20 designate or provide official tags for marking containers of
- 21 certified insulation.
- 22 Section 5. Labeling.
- 23 Six months after such standards are adopted as regulations in
- 24 accordance with the act of July 31, 1968 (P.L.769, No.240),
- 25 known as the "Commonwealth Documents Law," no insulation
- 26 material shall be manufactured, sold, offered for sale, or
- 27 exposed for sale within the Commonwealth in bulk, package or
- 28 containers, unless the package or container in which the same
- 29 shall be exposed or offered for sale shall have attached thereto
- 30 a tag or label on which shall be plainly written or printed,

- 1 where applicable the following information relating to
- 2 insulation:
- 3 (1) Thermal resistance.
- 4 (2) Composition of contents.
- 5 (3) Smoke spread rating.
- 6 (4) Flame spread rating.
- 7 (5) Weight of insulation.
- 8 (6) Corrosiveness.
- 9 (7) Moisture absorption.
- 10 (8) Starch content.
- 11 (9) Density.
- 12 (10) Odor emission.
- 13 (11) Flame resistance permanency.
- 14 (12) Installation instructions.
- 15 as determined by an independent approved testing laboratory.
- 16 Section 6. Department testing; inspection.
- 17 The department may conduct independent tests of insulation
- 18 material in order to determine compliance with its adopted
- 19 standards. The department may also conduct on site inspections
- 20 of manufacturers, distributors and retailers of insulation
- 21 material sold or installed within the Commonwealth in order to
- 22 determine their compliance with this act.
- 23 Section 7. Penalties.
- 24 Any person who violates the provisions of the act shall be
- 25 guilty of a misdemeanor of the third degree and upon conviction
- 26 thereof shall be subject to imprisonment not to exceed one year
- 27 or a fine not to exceed \$2,500, or both.
- 28 Section 8. Injunction.
- 29 Any person who violates or proposes to violate this act may
- 30 be enjoined from so acting by any court of competent

- 1 jurisdiction. Actions for injunctions under this section shall
- 2 be initiated by the Attorney General of the Commonwealth of
- 3 Pennsylvania.
- 4 Section 9. Civil penalty.
- 5 In addition to any penalty imposed pursuant to section 7, any
- 6 person who violates any provisions of this act may be liable for
- 7 a civil penalty not to exceed \$2,500 for each violation, which
- 8 may be assessed and recovered in a civil action brought in the
- 9 name of the people of the Commonwealth of Pennsylvania by the
- 10 Attorney General of the Commonwealth.
- 11 Section 10. Effective date.
- 12 This act shall take effect in 30 days.
