SENATOR SMITH, APPROPRIATIONS, IN SENATE, AS AMENDED,
JUNE 19, 1978

AN ACT

1 Making an appropriation to the Bureau of Professional and
2 Occupational Affairs in the Department of State for the
3 period between July 1, 1978 and June 30, 1979.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. (A) The sum of \$3,700,000, or as much thereof as ←
7 may be necessary, is hereby specifically appropriated from the
8 Professional Licensure Augmentation Account in the General Fund
9 to the Bureau of Professional and Occupational Affairs in the
10 Department of State for the payment of the costs of processing
11 licenses and renewals, for the operation of the various
12 licensing boards and for other general costs of bureau
13 operations for the period between July 1, 1978 and June 30, 1979

17 (B) IF NECESSARY, THE BUREAU OF PROFESSIONAL AND
18 OCCUPATIONAL AFFAIRS MAY TRANSFER FUNDS AMONG THE ALLOCATIONS
19 LISTED IN SUBSECTION (A): PROVIDED, THAT THE AGGREGATE AMOUNT
20 TRANSFERRED INTO OR OUT OF EACH ALLOCATION DURING THE FISCAL
21 YEAR SHALL NOT EXCEED 15% OF THE AMOUNT SPECIFICALLY ALLOCATED
22 FOR THAT PURPOSE.

23 Section 2. In the event that there are insufficient funds in
24 the Professional Licensure Augmentation Account to meet the
25 appropriation made by this act, funds may be borrowed from the
26 General Fund to alleviate this cash flow problem on the
27 condition that all such borrowed funds are repaid by June 30,
28 1979.

29 Section 3. This act shall take effect July 1, 1978 or
30 immediately whichever occurs last.
