SENATE BILL No. 1475 Session of 1978

INTRODUCED BY SMITH, MAY 22, 1978

AS REPORTED FROM COMMITTEE ON APPROPRIATIONS, HOUSE OF REPRESENTATIVES, AS AMENDED, JUNE 6, 1978

AN ACT

Amending the act of August 24, 1977 (P.L.452, No.12A), entitled 1 2 "An act appropriating the Federal augmentation to the 3 Executive and Judicial Departments of the Commonwealth and 4 establishing restricted receipts accounts for the fiscal 5 period July 1, 1977 to June 30, 1978 and for the payment of б bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1977; and requiring the 7 8 submission of certain budget reduction plans and authorizing the State Treasurer to withhold certain payments," increasing 9 the appropriations of Federal augmentation moneys to the 10 Office of Administration and the Departments of Education, 11 12 MILITARY AFFAIRS and Public Welfare. and adding an 13 appropriation to the Pennsylvania State Police.

14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows:

Section 1. As much of section 2 which relates to the Office 16 17 of Administration, the Departments of Education, MILITARY 18 AFFAIRS and Public Welfare of the Executive Department, act of August 24, 1977 (P.L.452, No.12A), known as the "Federal 19 Augmentation Appropriation Act of 1977," the appropriation to 20 21 the Department of Public Welfare, amended April 24, 1978 22 (No.9A), are amended and an appropriation to the Pennsylvania State Police, is added to read: 23

1 Section 2.
