AN ACT

- 1 Relating to legislative review of regulations.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the "Rules and
- 6 Regulations Review Act."
- 7 Section 2. Definitions.
- 8 The following words or phrases when used in this act shall
- 9 have, unless the context clearly indicates otherwise, the
- 10 meanings given to them in this section:
- 11 "Agency." Any department, departmental administrative board
- 12 or commission, independent board or commission, agency or any
- 13 other authority of this Commonwealth now existing or hereafter
- 14 created, but shall not include the Senate or House of
- 15 Representatives or any court, the Pennsylvania Fish Commission,
- 16 the Pennsylvania Game Commission, political subdivision,
- 17 municipal or local authority.

- 1 "Rule or regulation." Any regulation, proposed or adopted by
- 2 an agency prescribing or directing activity or forbearance. The
- 3 term shall not include a proclamation, executive order,
- 4 directive or other similar document promulgated by the Governor
- 5 but shall include a rule or regulation which may be promulgated
- 6 by an agency only with the approval of the Governor.
- 7 Section 3. Rules and regulations automatically reviewed.
- 8 (a) Each agency shall transmit any proposed rule or
- 9 regulation for approval to the appropriate House or Senate
- 10 Committee where the bill that is the basis for the proposal rule
- 11 or regulation originated. No rule or regulation may be
- 12 implemented without the approval of the appropriate committee.
- 13 (b) The committee shall set forth and transmit its findings
- 14 and decision to the head of the agency which proposed or adopted
- 15 the rule or regulation presented for approval.
- 16 Section 4. Placement on calendar.
- 17 (a) Any rule or regulation presented for approval to the
- 18 appropriate committee shall be considered and decided upon
- 19 within 15 legislative days. The committee shall not have the
- 20 power to amend the rule or regulation.
- 21 (b) In the event the committee fails to consider the
- 22 referral, then on the 15th legislative day after the referral is
- 23 received, it will be placed on the calendar and a vote shall be
- 24 taken thereon by the body of the House where the bill that is
- 25 the basis for the rule or regulation originated. If the vote is
- 26 not taken on that day, the referral shall automatically become
- 27 effective.
- 28 Section 5. Rejection of "proposed rule or regulation."
- 29 (a) A proposed rule or regulation may be rejected or
- 30 accepted if a majority of the committee is recorded as voting in

- favor of such action.
- (b) A proposed rule or regulation may be rejected or 2
- 3 accepted by a majority of the members elected to the House where
- 4 the bill originated if the committee does not act within the
- 5 time provided above.
- 6 Section 6. Effective date.
- 7 This act shall take effect in 60 days.
