AN ACT

Amending the act of July 20, 1968 (P.L.652, No.220), entitled "An act amending the act of March 31, 1949 (P.L.372, No.34), 2 3 entitled 'An act to promote the welfare of the people of the 4 Commonwealth; creating The General State Authority as a body corporate and politic with power to construct, improve, 6 equip, furnish, and operate projects, and to lease the same, 7 and to fix fees, rentals, and charges for the use thereof; 8 authorizing and regulating the issuance of bonds for said 9 Authority, and providing for the payment of such bonds, and 10 the rights of the holders thereof; and to enter into agreements with the Government of the United States or any 11 12 Federal agency; and authorizing the Department of Property 13 and Supplies to grant, assign, convey, or lease to the Authority lands of the Commonwealth and interests therein, 14 15 and to acquire lands therefor; granting the right of eminent domain; empowering The General State Authority to sell and 16 17 convey projects and property to the Commonwealth; and 18 providing that no debt of the Commonwealth shall be incurred 19 in the exercise of any of the powers granted by this act,' 20 empowering the Authority to construct and acquire projects 21 for certain State-related universities; providing for the disposition of unused borrowing capacity which may become 22 23 available through the operation of the Higher Education Facilities Act of 1963 or other Federal grants; harmonizing 24 25 the language of certain existing amendments; allocating 26 unused funds; providing for the interpretation of certain 27 amendments to the act; further defining the powers and 28 procedures of the board; regulating the leasing of projects 29 constructed for State-aided institutions; amending the 30 eminent domain powers and procedures of the Authority; 31 specifically itemizing projects for capital budget purposes, " 32 providing for an emergency capital project at California 33 State College to raze and demolish certain dangerous

- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Part XI of section 7, act of July 20, 1968
- 5 (P.L.652, No.220), entitled "An act amending the act of March
- 6 31, 1949 (P.L.372, No.34), entitled 'An act to promote the
- 7 welfare of the people of the Commonwealth; creating The General
- 8 State Authority as a body corporate and politic with power to
- 9 construct, improve, equip, furnish, and operate projects, and to

- 27 harmonizing the language of certain existing amendments;
- 28 allocating unused funds; providing for the interpretation of
- 29 certain amendments to the act; further defining the powers and
- 30 procedures of the board; regulating the leasing of projects

- 3 itemizing projects for capital budget purposes," is amended by
- 4 adding a project to read:
- 5 Section 7. For capital budget purposes the following public
- 6 improvement projects to be financed by the issuing of debt and
- 7 to be constructed by The General State Authority, its successors
- 8 or assigns, and which are in addition to those projects itemized
- 9 in the "Capital Budget Act for the 1968-1969 Fiscal Year" are
- 10 hereby specifically itemized, together with their respective
- 11 estimated financial costs, as follows:
