A SUPPLEMENT

- To the act of April 11, 1974 (P.L.252, No.62), entitled "An act authorizing the indebtedness, with approval of the electors, of one hundred million dollars for the repair, reconstruction and rehabilitation of nursing homes and providing the allotment of proceeds from borrowing hereunder," authorizing,
- 6 with approval of the electors, part of the funds for nursing
- 7 homes to be used for loans to repair, reconstruct and
- 8 rehabilitate boarding homes.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. The question of using the sum of \$60,000,000 UP
- 12 TO \$50,000,000 for loans for the repair, reconstruction of
- 13 boarding homes from the \$100,000,000 for nursing homes shall be
- 14 submitted to the electors at the next primary, municipal or
- 15 general election following enactment of this act.
- 16 Section 2. The Secretary of the Commonwealth shall forthwith
- 17 certify the question to the county boards of election.
- 18 Section 3. The question shall be in substantially the
- 19 following form:

- 1 Do you favor the use of \$60,000,000 UP TO
- 2 \$50,000,000 previously authorized for nursing Yes
- 3 homes to also be used for loans to repair, No

- 4 reconstruct and rehabilitate boarding homes?
- 5 Section 4. The election shall be conducted in accordance
- 6 with the act of June 3, 1937 (P.L.1333, No.320), known as the
- 7 "Pennsylvania Election Code," except that the time limits for
- 8 advertisement of notice of the election may be waived as to the
- 9 question.
- 10 Section 5. Proceeds of borrowing shall be used through loans
- 11 to provide for repairs, reconstruction and rehabilitation of
- 12 nursing homes and boarding homes necessary to insure compliance
- 13 with State and Federal safety standards.
- 14 Section 6. This act shall take effect immediately.
