AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, providing for the registration of noncommercial
- 3 trucks.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. The definition of "truck" in section 102 of Title
- 7 75, act of November 25, 1970 (P.L.707, No.230), known as the
- 8 Pennsylvania Consolidated Statutes, is amended and a definition
- 9 is added to read:
- 10 § 102. Definitions.
- 11 Subject to additional definitions contained in subsequent
- 12 provisions of this title which are applicable to specific
- 13 provisions of this title, the following words and phrases when
- 14 used in this title shall have, unless the context clearly
- 15 indicates otherwise, the meanings given to them in this section:
- 16 * * *
- 17 "Noncommercial truck." For the purposes of Chapter 13
- 18 (relating to registration of vehicles), a motor vehicle designed

- 1 primarily for the transportation of property, which:
- 2 (1) is not used or maintained for commercial purposes or
- 3 <u>for hire;</u>
- 4 (2) does not have a Gross Vehicle Weight Rating (GVWR)
- 5 in excess of 9,000 pounds; and
- 6 (3) does not bear any advertising, signs, lettering,
- 7 <u>names or addresses on its exterior, except for trademarks and</u>
- 8 <u>labels of the manufacturer and dealer.</u>
- 9 * * *
- 10 "Truck." A motor vehicle designed, used or maintained
- 11 primarily for the transportation of property. The term includes
- 12 <u>"noncommercial trucks" except as otherwise specifically provided</u>
- 13 for the purposes of Chapter 13.
- 14 * * *
- 15 Section 2. Section 1304 of Title 75 is amended by adding a
- 16 subsection to read:
- 17 § 1304. Registration criteria.
- 18 * * *
- 19 (h) Noncommercial trucks.--The department shall, at the
- 20 option of the applicant, register as a noncommercial truck any
- 21 truck which meets the criteria enumerated in the definition of
- 22 noncommercial vehicle in section 102 (relating to definitions).
- 23 The noncommercial truck shall be registered at the maximum
- 24 registered gross weight allowed pursuant to subsection (d) but
- 25 <u>in no event greater than 9,000 pounds.</u>
- 26 Section 3. Subsection (a) of section 1305 of Title 75 is
- 27 amended to read:
- 28 § 1305. Application for registration.
- 29 (a) General rule. -- Application for the registration of a
- 30 vehicle shall be made to the department upon the appropriate

- 1 form or forms furnished by the department. The application shall
- 2 contain the full name and address of the owner or owners; the
- 3 make, model, year and vehicle identification number of the
- 4 vehicle; and such other information as the department may
- 5 require. Applicants for registration of a truck, truck tractor,
- 6 <u>noncommercial truck</u>, trailer or bus shall provide the vehicle's
- 7 Gross Vehicle Weight Rating (GVWR), or the Gross Combination
- 8 Weight Rating (GCWR), as applicable. If the manufacturer's
- 9 ratings are not available, the applicant shall provide
- 10 sufficient information as to the horsepower, braking capacity
- 11 and such other data as necessary for the department to determine
- 12 an equivalent measure of the vehicle's hauling and stopping
- 13 capability. If the applicant wishes to register a vehicle at a
- 14 registered gross weight less than the gross vehicle weight
- 15 rating, the application shall include information as to weight,
- 16 load and any other such information as the department may
- 17 require. Applications and renewals for noncommercial truck
- 18 registration shall contain an affidavit that the truck meets the
- 19 criteria for such registration and that it will not be used or
- 20 operated in violation of such registration criteria for the
- 21 <u>duration of the registration period</u>. The application shall be
- 22 accompanied by proof of insurance and the applicable fee.

- 24 Section 4. Section 1308 of Title 75 is amended by adding a
- 25 subsection to read:
- 26 § 1308. Issuance of registration card.
- 27 * * *
- 28 (f) Noncommercial trucks. -- The registration card for a
- 29 <u>noncommercial truck shall indicate the registered gross weight</u>
- 30 of the noncommercial truck which shall be the lesser of the

- 1 vehicle's maximum gross weight allowed pursuant to section
- 2 <u>1304(d)</u> (relating to registration criteria) or 9,000 pounds.
- 3 Section 5. Title 75 is amended by adding sections to read:
- 4 § 1372.1. Unauthorized use of noncommercial truck.
- 5 (a) General rule. -- No person shall operate and no owner
- 6 shall permit to be operated on any highway a vehicle registered
- 7 as a noncommercial truck which is not in conformance with the
- 8 registration and operation criteria for noncommercial trucks.
- 9 (b) Penalty. -- Any person violating this section is guilty of
- 10 a summary offense and shall, upon conviction, be sentenced to
- 11 pay a fine of not less than \$50 nor more than \$300.
- 12 § 1916.1. Noncommercial trucks.
- 13 The annual fee for registration of a noncommercial truck
- 14 shall be \$24.
- 15 Section 6. This act shall take effect in 60 days.
